- 5. Increase inclusion in all schools school spirit increase participation in extracurricular activities
- 6. Utilize Board development opportunities with MTSBA
- 7. Increase parent involvement beyond elementary school
- 8. Expand trade and career readiness programs
- 9. Expand Breakfast after the Bell
- 10. Review Financial Statements for efficiency and cost saving opportunities

Goal #4 – Develop a blueprint for transitioning sixth (6^{th}) graders to East Middle School is thought to be a longer-term goal. A study should be done before any planning commences.

Goal #3 – Increase engagement of school board members in school activities was eliminated as Board members can do this on their own.

Goal#10 – Review Financial Statements for efficiency and cost saving opportunities was eliminated as Board members can review financial statements and ask questions any time.
