<b>Phase 1</b>	<b>Schools open for in person instruction limiting building capacity and group size</b>	<ul style="list-style-type: none"> <li>Health screening for students done at home.</li> <li>Handwashing and steps to limit germ transmission are pro-actively taught and dedicated time throughout the day</li> <li>Student groups will be kept together in Cohort Groups) and scheduled on an A/B schedule attending school 2 to 3 days weekly.</li> <li>Modified daily schedule</li> <li>Frequent sanitizing of surfaces and bathrooms</li> <li>Social Distancing maintained.</li> <li>Face coverings required for grades 7-12 when social distancing is not possible and when transitioning throughout the day. Face coverings recommended at K-5 when transitioning when feasible and appropriate.</li> <li>No visitors will be allowed in the building.</li> <li>Playground equipment will be sanitized between usage.</li> <li>Extensive training on proper procedures and protocols for disinfecting, reporting symptoms, proper techniques for wearing PPE, social distancing, provided to all staff and students.</li> <li>Parent training on home health screenings, wearing masks, social distancing, and hand sanitizing will be available online.</li> <li>Physical distancing for all adults is mandatory</li> <li>All classrooms will be equipped with proper PPE and supplies.</li> </ul>	<ul style="list-style-type: none"> <li>Blended learning model District will implement an A/B schedule utilizing both an in person and remote learning model. Buildings would be reduced to half capacity. Students would be scheduled in cohorts and reduced to an A/B schedule.</li> <li>A/B: half of the student body attends on A days; the other half attends on B days. Students will continue in their cohort groups throughout the day. Schedules would be developed to keep family members attending school on the same days as much as possible.</li> <li>Modified daily schedule</li> <li>Lunch in the classroom</li> <li>No large gatherings or assemblies</li> <li>This plan would be implemented if allowable group size went below 50 and building capacity was limited.</li> <li>No extra-curricular activities</li> <li>All school facilities will be closed to public rental.</li> <li>Community Education Program canceled to in person instruction</li> <li>Administrative/Staff meetings should be conducted if at all possible via TEAMS Meeting platform.</li> </ul>

<p><b>Phase 2</b></p>	<p><b>Schools open for in person instruction. Limits group size to 50</b></p>	<ul style="list-style-type: none"> <li>• Health screening for students done at home</li> <li>• Student training on handwashing, social distancing, and wearing masks will be taught to students on a regular basis.</li> <li>• Dedicated hand washing will be scheduled throughout the day</li> <li>• Masks/face coverings will be mandated grades 7-12 when social distancing is not feasible and during all transition times. Masks and face coverings for students in grades K-5 when transitioning and when appropriate.</li> <li>• Outside venues will be encouraged whenever possible especially when developing traffic routes at individual buildings</li> <li>• No large gatherings or assemblies</li> <li>• Lunch in the classroom</li> <li>• No visitors will be allowed in the buildings</li> <li>• Frequent sanitizing of surfaces and bathrooms</li> <li>• Reduced rider capacity on buses</li> <li>• Board meetings will be conducted using a blended model including remote and/or in person meetings.</li> <li>• Extensive training on proper procedures and protocols for disinfecting, reporting symptoms, proper techniques for wearing PPE, social distancing, provided to all staff and students.</li> <li>• All classrooms will be equipped with proper PPE and supplies.</li> </ul>	<ul style="list-style-type: none"> <li>• In person instruction for all students 5 days a week, limits group size to 50 persons or less includes some remote learning activities.</li> <li>• Modified School Day Schedule. (See attached modified schedule) This modified schedule allows for lunch in the Classroom, proper daily sanitization, and allows for cohort scheduling).</li> <li>• Students will be assigned to cohorts in order to limit large group gatherings (Cohorts - students attend school, but students will only participate in 2 classes during the day for middle school and high school students to limit exposure to 50 or less individuals. Elementary homerooms will make up the cohorts in each grade level K-6.) All transitions will be staggered to avoid congestion.</li> <li>• Lunch will be in the classroom, and recess will be scheduled with cohort group.</li> <li>• Extra-curricular activities will be scheduled to reduce exposure and to keep students in the same cohorts. These schedules will be developed based on the guidelines from MHSA, the governor's reopening plan, CDC recommendations, and the Butte Silver Bow Health Department. Specifics for each activity will be provided as soon as we have more information.</li> <li>• Bell schedules will be modified and staggered to reduce traffic in hallways, entrances/exits, gym areas.</li> <li>• Administrative/Staff meetings should be conducted if at all possible via TEAMS Meeting platform.</li> <li>• Parents have an option to continue with remote learning. Community Education Program canceled for in person instruction</li> <li>• Administrative/Staff meetings should be conducted if at all possible via TEAMS Meeting platform.</li> <li>• All school facilities will be closed to public rental.</li> </ul>

Phase 3	<b>All restrictions are lifted</b>	<ul style="list-style-type: none"> <li>• Student training on hand washing and healthy hygiene practices will continue to be taught on a regular and consistent manner</li> <li>• Continue to follow all disinfecting and cleaning protocols</li> <li>• Health screening for students to be done at home.</li> <li>• Visitors may be allowed in the buildings.</li> <li>• Continue to follow social distancing and wearing masks when appropriate.</li> <li>• Extensive training on proper procedures and protocols for disinfecting, reporting symptoms, proper techniques for wearing PPE, social distancing, provided to all staff and students.</li> </ul>	<ul style="list-style-type: none"> <li>• In person instruction all students 5 days a week.</li> <li>• Return to regular school daily schedule</li> <li>• Lunch room schedules resume</li> <li>• Recess schedules resume</li> <li>• Transportation schedules resume to full capacity</li> <li>• Extra-curricular activities operate at full capacity.</li> <li>• Rental agreements restored to normal practices.</li> <li>• Community Education Program return to in person instruction.</li> <li>• Administrative/Staff meetings resume to in person meetings.</li> </ul>
