The Board of Trustees held a Special Meeting on Monday, May 17, 2021 at 4:15 p.m. at West Elementary School with Chairperson Ann Boston presiding. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

CANVASS VOTES FROM MAY 4, 2021 ELECTION

Kevin Patrick passed out Tally Books and the Board reviewed them for accuracy. A discrepancy of five (5) votes was found and corrected on the FOR votes for the Levy, changing the total from 4,048 to 4,083. Trustee Hepola made motion to approve the Canvass, second by Trustee Lee. Motion carried unanimously.
