COMMUNICATIONS

Item 4.1 - Special Education Presentation

Melissa Johnson, Director of Special Education, presented to the Board of Trustees. Melissa began her presentation with photos of Special Olympics Basketball when they came to Butte. Melissa stated the unified team from East won the metal and that it was a super positive experience for all the kids. Melissa then updated the board on unified schools, she stated 7 schools are involved. Melissa showed photos of Whittier, West and Emerson demonstrating inclusion with parades and signing to be all inclusive. Melissa also showed a slide with photos of Special Olympics bowling in Bozeman and stated that MedFest is giving free physicals for Special Olympics kids. She proceeded with her presentation by discussing Shoes for the Sole, on this day, individuals can donate \$1.00 each day to wear sweats or donate if they wish. Shoes for the Sole earned \$2,085.00 this year and proceeds goes towards Special Olympics for activities. Melissa then updated the board on Pre-ETS transitions services. She stated there are 10 students in the elementary lunchrooms. They help out with wiping tables, helping with cleanup, etc.. She said this really helps them gain experience. Item 7.3 - Approval of Permissive Levy Notice

Judy Jonart, Superintendent, presented on behalf of Kevin Patrick, Director of Business Affairs. Judy requested approval for the Elementary and High School resolution of intent to increase nonvoted levy. She stated the Butte School District #1 Board of Trustees is required by law to adopt a resolution. The Butte School District #1 Board of Trustees estimates the following increases/decreases in revenues and mills for the funds noted below for the next school fiscal year beginning July 1, 2023, using certified taxable valuations from the current school fiscal year as provided to the district. Jonart stated that the information provided below is estimated based on current year information and not information for the ensuing fiscal year. Accurate numbers for ending fund balance, reserves and reappropriation, all of which affect permissive tax levy revenue, are not known until after the fiscal year end books are closed, after June 30th. Taxable value for the FY2024 budgets, which is used to calculate the number of mills needed to generate tax levy revenue, is not received from Dept. of Revenue until Aug. 1.

Judy also stated that the notice must also document the District's expected use of its Building Reserve State Major Maintenance levies and associated funding. This year, the District expects to use those proceeds to fun deferred maintenance, capital improvements and operational costs of school safety. The District estimates this funding structure will generate approximately \$516,420.00 during 2023-24. The estimated mills are approximately 3.61.

Trustee Hepola made a motion to approve, second by Trustee Lee. Motion carried unanimously.

Item 7.4 - Approval to Cancel Elementary General Fund Levy Portion of Election

Judy Jonart, Superintendent, presented on behalf of Kevin Patrick, Director of Business Affairs. Judy stated the Elementary District General Fund levy election ballot for the May 2, 2023 school election would call for a \$81,090.69 levy, which is approximately 1.15 mills. The durational limit of the levy is permanent once approved by the voters. Assuming the district levies that amount at least once in the next five years. The estimated tax increase on a \$100,000.00 home would be \$1.55 and the estimated tax increase on a \$200,000.00 home would be \$3.11. Judy recommended canceling the levy portion of the election for the May 2, 2023 school election and increase the general fund over-base for FY 24.

Ann Boston, Chairperson stated that it would cost the district approximately \$51,000.00 to run an 81,000.00 levy.

Trustee Hepola made a motion to approve, second by Trustee Lee. Motion carried unanimously.

ADJOURNMENT

There being no further business to come before the board, Trustee Hepola moved to adjourn, second by Trustee Lee. Motion carried unanimously. Chairperson Boston adjourned the meeting at 5:25 p.m.
