- 2. The Butte School District Board of Trustees will support the efforts of a health trust as it relates to House Bill 332 Bridged Health Alliance.
- 3. Enhance technology resources in an effort to address learning loss and enhance instructional practices to meet the needs of all students and staff.
- 4. To address learning loss for all students the Butte School District will offer extended learning Summer and Afterschool Programs for all PK-12 students to meet all individual needs. during the 2024-2025 school year.
- Provide the necessary personnel to support individual needs of all PK-12 students. in an
 effort to address learning loss.
 To maintain all health actions to minimize the spread of infection.
- 6. Continued Pursue proper upgrades to all district facilities Butte School District #1 to enhance the health and safety of to all students, staff, and families.
- 7. Implement all elements of Early Literacy Learning Targeted Intervention Programming PK-3.
- 8. To ensure family and parental rights are made available on an ongoing basis and in compliance with §20-7-120, MCA.
- 9. As a Board develop a strategic plan and strategy for passing levies.

The Board also updated the year to the Strategic Plan on page 1 and added language to Goal Area 2 (page 7). Below are the changes:

- 5. We will enhance our use of technology as a tool that enhances teaching and learning opportunities, which will also include AI framework.
- 7. We will facilitate the implementation of the Butte School District Pathway Academy Charter School to ensure the goals and protocols are in compliance.
- 8. The Butte School District will offer extended learning summer and after school programs to PK-12 students to meet all individual needs.
- 9. Implement all elements of Early Learning Targeted Intervention Programming Pre- K-3.
