The Board of Trustees held a Special Board Meeting on Monday May 18, 2026, at 4:33 p.m. in the East Middle School Library with Chairperson Ann Boston presiding. Trustees present were Tom Billteen, Patti Hepola, Mike Kujawa, Kathy Milodragovich and Jorey Thatcher. Trustee Lee and Klobucar were absent. Also present were Judy Jonart, Superintendent, Keith Miller, Assistant Superintendent, Karen Alley, Director of Human Resource and Kevin Patrick, Business Director.

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

CANVASS VOTES FROM MAY 5, 2026 ELECTION

Kevin Patrick, Business Director, received the official results for the Butte High Technology fund levy. 4,188 voted for the levy and 2,742 voted against. There were 3 overvotes and 126 undervotes. The Elementary General fund levy had 4,024 for and 2,468 against. There were 2 overvotes and 25 undervotes.

Trustee Kujawa motion to approve, second by Trustee Milodragovich. Motion carried unanimously.
