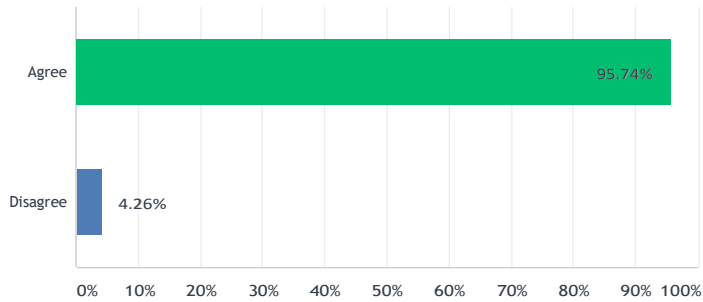


Q1 After reading the above quote, do you agree to KCSC members having staggered terms?

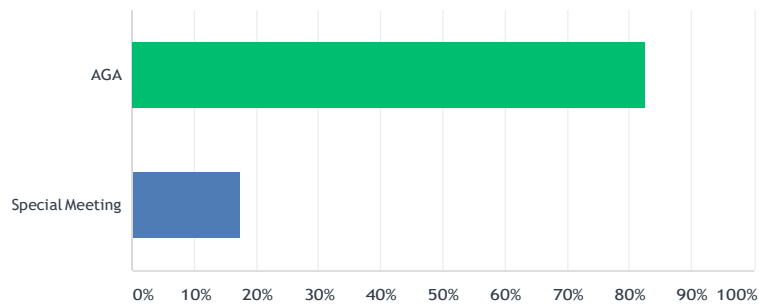

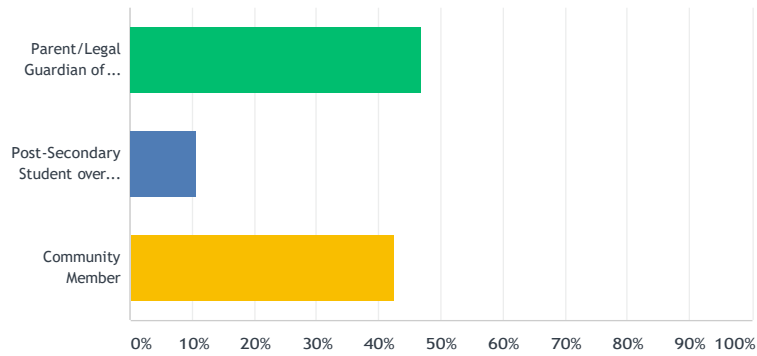

Q3 Which group are you a member of:

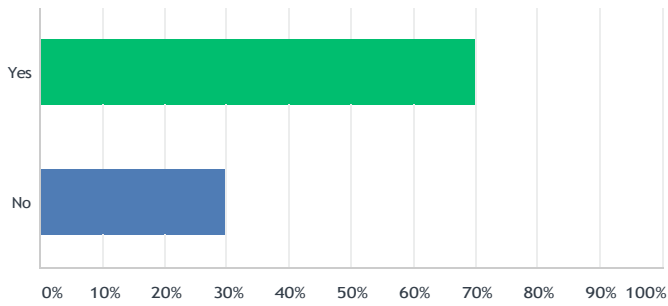

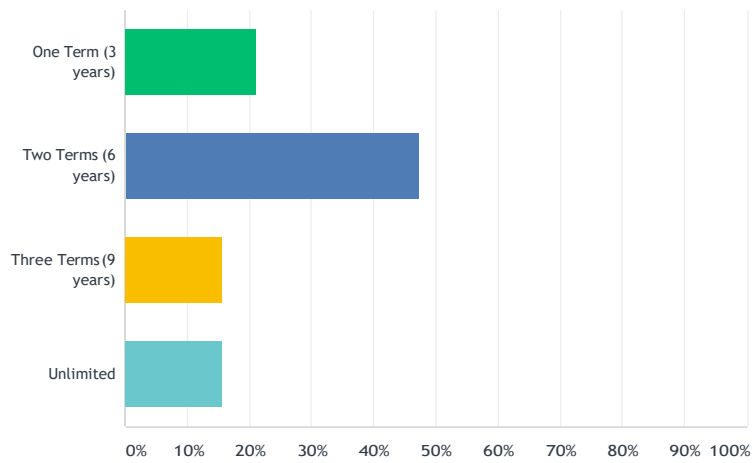

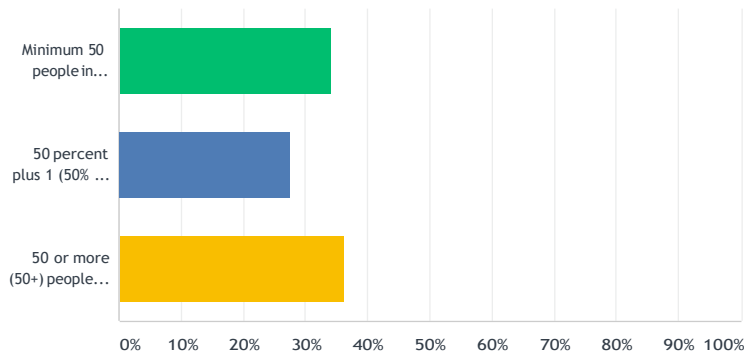
