
Key Messages

- 1) The health & well-being of students, families, & staff is priority #1.
- 2) Our focus for the coming year is to develop a safe school environment for our students and staff that prioritizes everyone's well-being and enables high levels of learning for all.
- 3) We are planning based on guidance from the MA Department of Elementary & Secondary Education while closely monitoring the latest information from medical experts and the evolving data regarding the pandemic both in Massachusetts and in Shrewsbury.



Important to Note

- Tonight's presentation is NOT the proposed reopening plan. A recommended plan will be presented next week (August 5)
- Our staff is working extremely hard to create the best plan possible given the information and guidance we have
- This is an extraordinary situation that will require ongoing iteration to respond to changing circumstances



If our school district implements an in-person learning model for all students based upon the state guidance (3 foot physical distancing):

Remote Learning 2.0

- Both educators and families want instructional plans to include more "live" time with students, and so remote learning guidelines will be adjusted to reflect much more time on learning.
- It's expected that students will fully participate in Zoom sessions. Attendance will be taken and expectations for student responsibilities will be communicated proactively.
- Student work will be collected regularly, assignments will be graded, and educators will revert back to the same grading systems that were in place before school closure.
- We have software tools to help differentiate learning at all levels.

Why consider a hybrid model?

- A SAFE return to in-person learning in any capacity is better educationally than a continuation of remote learning, assuming that a safe return is possible.
- An alternating in person / remote plan will allow educators to more consistently connect with and effectively engage ALL students.
- Skillful teaching is informed by assessment, and assessment is best done in person.



What MIGHT this look like?

This will mean dividing students into cohorts:

Cohort A: High needs students attend every day

Cohorts B/C: These students will alternate days (plan is to have cohorts by last name to ensure children from the same family are on the same schedule)

Cohort D: Students opting for continuing to learn remotely will be taught by a separate group of educators, possibly through a third-party platform.

- This will also mean adjusting the academic day (during in-person days to allow for safety measures and on remote days to raise expectations for student work)
- This will mean building time for planning as well as teaching.

Key Data Points: Willingness To Return to School

- 67% of students would return for an alternating hybrid schedule with fewer students, with 17% not returning and 16% undecided
- Slightly higher for high school (74%), slightly lower for elementary (59%)

Continued Planning for Reopening

- Analysis of 3 options due to Department of Education by July 31; decision for SPS due by August 10; School Committee meeting August 5 to vote on plan
- Reopening Task Force Subcommittees are working to resolve details for the recommendation to School Committee next Wednesday

Continued Planning for Reopening

- New information from DESE regarding delaying the start of school for students by 10 days to enable thorough training and orientation
- An updated school calendar will be brought forward for School Committee approval as part of the reopening plan

Continued Planning for Reopening

- Specific family choices for each student for either participating in the hybrid model or fully remote learning will be requested through PowerSchool Parent Portal once a plan is approved
