April 10 Testing Day at DGN

Dear North High School Students and Parents:

Tuesday, April 10, 2018 will be Testing Day at DGN. All freshmen through juniors must report to their assigned testing rooms by 8 a.m. Seniors are not required to attend school. Freshman and sophomore students will complete testing by approximately 11:15 am and juniors will complete testing at approximately 12:50 p.m. There will be two bus runs, one after the 11:15 a.m. testing and one after the 12:50 p.m. testing. Please note that students who test with accommodations may test beyond that timeframe, and transportation will be arranged accordingly.

SENIORS: Tuesday, April 10 is a non-attendance day.

JUNIORS: **All high school juniors in the state of Illinois are required to take the SAT on Tuesday, April 10.** This battery of tests is used by the Illinois State Board of Education to assess high school students' learning. In addition, District 99 and South use the results to chart progress and set learning priorities. Testing classrooms will be posted throughout the building a couple of days before testing. On April 10, students must report to their assigned classroom by 8 a.m.; testing will conclude by 12:50 p.m. Since this is a required state assessment, any absent students will be assigned to test on a make-up date.

SOPHOMORES: All sophomore students will take the PSAT 10 in the Purple Gym from 8 a.m. until approximately 11:15 am.

FRESHMEN: All freshman students will take the PSAT 8/9 in the Field House from 8 a.m. until approximately 11:15 am.

All students must bring with them a picture ID (school ID card or driver's license), two sharpened #2 pencils, and a permissible calculator. The [CollegeBoard's Calculator Policy](#) along with the list of permissible calculators is provided on their website. SAT has well-defined parameters prohibiting the use of certain calculators. Students will not be permitted to use prohibited calculators on testing day, nor are students permitted to return

to their lockers once testing begins. Students may bring bottled water and a light snack to be stored under their desk and consumed during an approved break time.
