This is the subsequent 45 day **final** report after the initial 30 day report submitted) 5/21/2020 of the use of student funds received under Section 18004(a)(1) of the CARES Act

- Anabaptist Mennonite Biblical Seminary signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students on April 21, 2020.
- The total amount of funds that AMBS received \$6219.00 from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
- \$3600.0 of Emergency Financial Aid Grants was distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter). AMBS will gather applications in the next 45 days again for students who are affected by the Covid 19 pandemic and will distribute the full remaining funds of the \$6219.00 as we anticipate that there will continue to be economic disturbances amongst our students due to the Covid 19 pandemic. There has been a second email sent out inviting students to apply for the remaining funds.
- 66 students at AMBS were eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
- 3 students received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act during the first disbursement. 3 different students received the second disbursement.
- Our Student Services Director, Mary Ann Weber notified students through announcements and emails for eligible students to apply for Emergency Financial Aid Grants. Daniel Grimes, VP of Advancement and Enrollment; Mary Ann Weber, Enrollment Counselor and Student Services Director, and Teresa Sherrill, Enrollment and Financial Aid Specialist met and decided according to eligibility requirements and application content which students would receive a disbursement under Section 18004(a)(1) of the CARES Act, We decided to give 3 more students funds. Their applications gave evidence of technology challenges that needed addressed due to the pandemic. With the six students receiving funds, we have now spent the \$6,219 allotted to the student portion of the funds.
- Students were informed in the announcement that these Emergency Financial Aid Grants are to be used for food, housing, course material, technology, health care, or child care related to disturbances related to the Covid 19 pandemic.
