PARENT/GUARDIAN:

1. Complete the Affidavit of Residency Parent/Guardian form.
2. Submit **two** documents from the following list:
 - Driver's license or State ID
 - Voter registration card
 - Vehicle registration card
 - Public Aid card
 - Cell phone bill

OWNER OF RESIDENCE:

1. Complete the Affidavit of Residency Owner of Residence form.
2. **Category I** - submit **one** of the following proofs of ownership:
 - Current closing papers
 - Signed and dated lease with two rent receipts
 - Mortgage statement or payment book/coupon
 - Most recent property tax bill

Category II - submit **two** of the following proofs of ownership:

 - Driver's license or State ID
 - Voter registration card
 - Current utility bills – gas, electric, water, cable, phone (not cell)
 - Public Aid card
 - Vehicle registration card
 - Homeowner's or renter's insurance premium receipt
