STUDENT/PARENT AGREEMENT AND PERMISSION FOR USE OF CHROMEBOOK\*

The Student and his/her Parent/Guardian understand **and agree** as follows:

The Student will be issued a Chromebook, and a Google Apps for Education account by St. George CCSD no 258 ("the School District"), for the Student's use OUT-OF-SCHOOL.

The Chromebook is and **remains the property of the School District.**

The Parent/Guardian allows and accepts responsibility for their student to use the Chromebook.

Students are required to comply with Agreement, Board Policy 6:235 (including all subsections). Students will be subject to loss of privileges, disciplinary action, and/or appropriate legal action for any disobedience of the requirements listed in the above documents, or for any inappropriate use of the District owned Chromebooks.

The **user agrees to reimburse the School District** for any losses, costs, or damages, including reasonable attorney fees, incurred by the District relating to, or arising out of, any breach of this Agreement.

Students have no **expectation of privacy** in the use of District owned Chromebooks or District provided Google Apps for Education accounts and agree to the monitoring and inspection of either by school officials at any time. Files stored and information accessed, downloaded, or transferred are not private (including but not limited to emails, messages or files sent or received using the District's Internet connection, and/or messages or files stored on the Chromebook).

**Students must keep their District issued Chromebooks secure and damage free.** Care of Chromebook includes keeping food, water, animals, etc., away from Chromebook, keeping Chromebook out of areas where stepping/sitting occurs, not leaving Chromebook unattended and not using as a folder or stacking books or other items on top of the Chromebook. Vandalism or destruction of the Chromebook hardware or software is prohibited and **will be charged at the replacement cost of the Chromebook.** It may also result in criminal charges. **A repair charge will be assessed by the district and additional restrictions may be placed by the schools for any damage/loss of chromebook and/or it's accessories.**

**Loaner and Replacement Chromebook that is issued to the student is under the same obligations while in the student’s possession.**

Students may not download and/or install any programs, files, or games from the Internet or other sources onto any District-owned Chromebook. Students are prohibited from overriding, bypassing, or otherwise changing the Internet filtering software or other network configurations. Students must use District-owned Chromebooks for school-related purposes only.

Students may not make use of materials or attempt to locate materials that are unacceptable in a school setting. This includes, but is not limited to pornographic, obscene, graphically violent, or vulgar images, sounds, music, language, video or other materials (files). The criteria for acceptability is demonstrated in the types of material made available to students by administrators, teachers, and the school learning resource center.

Wireless network use outside of school district is the responsibility of the Student/Parent both in cost and configuration.

**We agree to abide by the conditions listed above and assume responsibility for the care and proper use of the District-owned Chromebook. We agree our student is responsible for how the Chromebook is used and cared for.**

We understand and agree that the **District is not responsible** for any loss resulting from Chromebook errors, delays, lost data, or service interruptions.

We understand that should we fail to comply with the terms of this Agreement, **use of the Chromebook may be restricted** and our student may be subject to disciplinary action and/or appropriate legal action

4. I agree **my student is responsible** for how the Chromebook is used and cared for and will be held accountable to fulfill the policies the student's school incorporates for the repair of and loaner\* for his/her Chromebook.
  
5. I agree to **not** hold St. George CCSD No. 258 (and its Board of Education, Board members, officers, employees, volunteers, and agents) responsible for any loss, damage, or legal liability that may arise under this agreement.

By signing below I agree that my student will be allowed to have the Chromebook **outside of the school**, and agree the Chromebook will be my and my student's responsibility at all times.
