FORMER/CURRENT FRC OR TRANSFER STUDENT APPLICATION EQUINE AND RANCH MANAGEMENT BACHELOR OF SCIENCE PROGRAM

Early Decision for Spring Semester Admission	October 1	November 2

The information provided in the application will be used to determine the applicant's eligibility for the program. If this application is incomplete or supporting documents are inconsistent with the information submitted in the application, the prospective student may be disqualified from the selection pool. Applicants will be selected based on academic standing, work/volunteer experience, personal accomplishments, and career goals. The selection process will be completed by February 15, or August 1 for late admittance.

It is the responsibility of the applicant to be sure that Feather River College has received all documents by the stated application deadline. Questions can be directed to the Admissions Office at 530-283-0202, ext. 222 or 285.

STEPS FOR A COMPLETE APPLICATION:

- 1. Complete the Feather River College General Admission Application** available at www.frc.edu. Click on *Apply Now* at the top of the page. *Current FRC students do not have to complete this step.*
- 2. A Personal Statement is required to be uploaded and submitted with the Online Application (Step 3).** Your personal statement is your opportunity to tell us about yourself to let us know about your ambitions and why you think FRC's Equine and Ranch Management program is the right fit for you. Be open. Be reflective. While the personal statement is only one of the many factors we consider when making our admission decision, it helps provide context for the rest of your application. Your personal statement must address the three prompt questions below and must be no more than three typed pages of 12 pt. font. Also, be conscious of spelling, grammar, and syntax. It is recommended that you save your personal statement as a Word document or PDF for uploading to the application.

Prompt Questions:

- Describe your personal interests and goals in Agriculture, Animal Science, or Management.
- Describe your past experience and/ or achievements and how they relate to your personal or professional aspirations, interests, and goals.
- Describe your career expectations regarding Feather River College Equine and Ranch Management



Bachelor of Science Degree and how they will integrate your personal interest and goals with a degree.

3. **Complete the [Equine and Ranch Management Bachelor of Science Application for Former/Current FRC or Transfer Student](#).** Remember that you will be asked to upload your Personal Statement before you will be able to submit your application. It is recommended you complete the Personal Statement before completing the online application. You can save and return to the application until completed, but once submitted you cannot go back and change items within the application.
4. **Official transcripts from colleges attended, other than FRC, are required.** Submit transcripts by the application deadline to the Admissions and Records office at the address below.
5. If you completed Advanced Placement (AP) courses, official scores for all courses that you wish to be considered for college credit must be submitted to the Admissions and Records office by the first day of the semester in which you enroll.
