## **JOB SUMMARY:**

Responsibilities include greeting guests, scheduling meetings and appointments, making office supplies arrangements, and providing general administrative and program support to the Chancellor and Vice Chancellors. Serves as primary point of operational and administrative contact for internal and external constituencies, often on complex and confidential issues. Coordinates the provision of office and staff support to the Lacombe Campus, and oversees and/or participates in the coordination, supervision, and completion of special projects and/or events. Many serve on a variety of committees in a support capacity.

## **Minimum Qualifications:**

Bachelor's degree from an accredited college/university in the field of Business Administration or a related field, and two years related work experience; **or** an Associate's Degree with seven (7) years related work experience in office management.

## **RESPONSIBILITIES:**

- Provides confidential secretarial and administrative support for the Chancellor and Vice Chancellors, to include managing schedule/calendar, making travel arrangements, screening and handling telephone communications for the Administrative office, greeting and directing visitors, and dealing with administrative problems and inquiries as appropriate.
- Will be customer driven and student oriented in all communications with stakeholders.
- Serves as a primary point of direct administrative contact and liaison with other offices, individuals, and external institutions and agencies on a range of specified issues; organizes and facilitates meetings, conferences, and other special events, as required.
- Organize office operations and procedures.

- Manages the reception area to ensure effective telephone and mail communications both internally and externally to maintain professional image.
- Coordinate with IT, Facilities, and Purchasing departments on all office equipment.
- Gathers, enters, and/or updates data to maintain departmental records and databases, as appropriate; establishes and maintains files and records for the office.
- Serves as HR liaison for the campus. Duties includes, assisting with the completion of campus staffing request forms, new hire orientation packets, assisting with timesheet completion process, and tracking/reconciling leave for the campus.
- Monitors and coordinates accounting activities as appropriate, and prepares internal reports for management; participates in budget planning and management, as required.
- Coordinates with external vendors and professional services and Director of Facilities, provided to the campus which include, but are not limited to, vending, pest control, and copying services.
- Checks in deliveries from UPS, FedEx, etc. and informs the proper individuals/departments that items ordered have been received. Sends required documentation to purchasing upon delivery. Maintains a filing system for purchase requisitions.
- Responsible for assisting with approved grant proposals by tracking the approvals through the purchasing, receipt and inventory process.
- Assists with project development and planning to ensure more efficient service and organization of the office.
- Composes and prepares written documentation and correspondence for the office; screens and evaluates incoming and outgoing correspondence and prepares responses as appropriate.
- Assists in the coordination, supervision, and completion of special projects as appropriate.
- Coordinates and oversees the day-to-day management of supplies, equipment, and facilities for the campus, as appropriate, to include maintenance, inventory management, logistics, security, and relative activities.
- May supervise personnel which may include recommendations for hiring, performance evaluation, training, work allocation, and problem resolution.
- Enhances professional growth and development through participation in educational programs, current literature, in-service meetings, and workshops.
- Perform other related duties as assigned.

### **SPECIAL SKILLS AND ABILITIES:**

1. **Skills/Abilities:** Application and intermediate knowledge of office practices and procedures. Ability to maintain a high level of accuracy in preparing and entering information. Intermediate computer skills to include spreadsheet and word processing programs, and e-mail at a highly proficient level. Have stress management skills and time management skills. Effective phone etiquette skills. Must be able to communicate effectively in both written and verbal form. Must maintain confidentiality of work related information and materials. Must establish and maintain effective working relationships. Excellent customer service skills. Have analytical and problem solving skills. Decision making skills. Should have knowledge of document-imaging technology.
2. **Equipment Used:** Personal Computer and other equipment associated with a general office environment (copier, telephone, fax, etc.)
3. **Software Used:** A variety of word-processing, spreadsheet, database, e-mail, and presentation software.

### **PHYSICAL REQUIREMENTS:**
