1. LSC Chair Monte Luzadder called the meeting to order and roll call was taken.
2. Monte Luzadder moved to approve the agenda for tonight’s LSC meeting. Peggy Herrington seconded the motion. Passed unanimously.
3. Monte Luzadder moved to approve the minutes from the LSC meeting on 2/16/17. Arnold Davis seconded the motion. Passed unanimously.
4. Public Participation: None.
5. New Business:
  - a. Approval of Internal Accounts for February: all LSC members received copies of Internal Account reports from Principal Karafiol. The school received back \$75,000 back from CPS after the freeze. Arnold Davis moved to approve the internal accounts and Drew Erdelack seconded the motion. Passed unanimously.
  - b. Approval of Budget Transfers & Adjustments: all LSC members received copies of non-personnel budget report. Monte Luzadder moved to approve the budget transfers and adjustments, and Ana Breen seconded the motion. Passed unanimously.
  - c. Approval of Rental Agreements: Chicago Cubs want to rent out auditorium and ten classrooms for \$4,000 on 3/24 and 3/25 for training. Monte Luzadder motioned to approve. Anna Proni seconded the motion. Passed unanimously.

- d. Approval of Fundraisers: Girls Soccer would like to sell raffle tickets to raise money for new uniforms. Their plan is to sell 800 tickets at \$5.00 each with a net profit of \$750. The Dance Club would like to sell candy bars (not in school) and hoping to raise \$1,500. JROTC would like to sell raffle tickets at the Military Ball. They hope to sell 1,600 tickets at \$5.00 each with a net profit of \$6,400. Girls Softball will be having a fundraising event at Chipotle, 3312 N. Western, on 04/07. 50% of proceeds that day from 4-8pm will go to the team. PAC would like to pay the registration fee for parents to attend a conference. Total cost would be \$2,129. This was not listed on the agenda for tonight's meeting and the LSC decided they needed more information before approving. Drew Erdelack moved to approve and Arnold Davis seconded the motion.

Sarah reported that the following info came from a survey they asked participants to complete: 21% had a current 8<sup>th</sup> graders; 65% had current middle schoolers; 26 different elementary schools were represented (14 feeder and 12 other); 42% said presentation changed their opinion of LVHS; 29 of 52 stated it is likely they will attend LVHS.
