1			I/We understand that the iPad and its accessory equipment are the property of the Auburn Public Schools.
2			I/We understand that the student, with the support of the parent, is responsible for the daily care and maintenance of the iPad.
3			I/We understand and agree to abide by the rules and regulations of the APS Technology Acceptable Use Policy. Failure to do so will result in disciplinary action.
4			I/We understand that the iPad will be returned to the District's discretion for upgrades and maintenance.
5			I/We understand that I/we must report all iPad damages or the theft/loss of the device to the technology department or building administration immediately with a police report filed for any theft.
6			I/We understand that the iPad must be in a District-provided case at all times as a reasonable precaution against damage.
7			I/We understand that all students must have their fully charged iPad device with them each day for every class.
8			I/We understand that the iPad must be returned to the District upon unenrollment from the Auburn Public Schools. Failure to return the device will result in report a to the Auburn Police Department.

2			I/We understand that an insurer will not cover loss or damage caused by your dishonesty or anyone acting for you. Nor would an insurer cover any loss or damage arising from your illegal acts. Insurers will also not cover loss or damage caused by your intentional damage or destruction of property covered under this policy.
3			I/We understand that insurance policies contain the complete details of coverage and it takes precedence over any language contained in this document.
4			I/We also understand that in the event that the iPad is stolen or lost, regardless of the circumstances, I/we will be responsible for the full replacement cost of the iPad if it is not covered by insurance.
5			This iPad Agreement, other than possible changes by the insurer, shall remain in effect until the iPad is returned or a new agreement is signed.
6			I/We understand that the District will renew the insurance policy annually and I/We will be responsible for the annual premium.
7			I/We understand that the District may provide financial assistance to assist in paying the insurance premium to families that require it. I/We may be asked to provide financial information to justify the assistance.

Auburn Public School (APS) iPad Agreement Principles and Declaration

The optional Auburn Insurance Policy will cover your iPad against a variety of losses and accidental damage. We encourage you to read this easy to understand document. The cost of the insurance policy is \$50.00 per year.

The words you, your, and yours mean the person(s) or organization(s) named as the Named Insured on the "Auburn iPad Insurance Policy Declarations" page. We, us, our, and ours mean the company as indicated on the "Auburn iPad Insurance Policy Declarations" page providing this coverage.

Your policy includes an **Insuring Agreement**, which is an explanation of "What to Do If You Have a Loss or Accidental Damage," along with general rules and conditions. The coverage, serial numbers and limits of insurance provided by your policy and your premium are displayed in items shown on your declarations page.

Intentional damage of any kind is **not** covered by this insurance policy. Furthermore, the insurance policy will **not** cover any damage occurring while the iPad was not properly stored in the District-provided case.

The Insuring Agreement

Limit of Insurance: The limit of insurance for your coverage, as shown on the "Auburn Insured Policy Declarations" page, applies to all issues arising from any two covered events or one theft during one policy period.

What This Agreement Covers: We will cover direct physical loss caused by accidental damage, fire, flood, vandalism, natural disasters and power surge due to lightning occurring during the policy period to the iPad, including items entrusted to you, worldwide, as long as the items were in your possession and reported to us.

The policy will also cover accidental damage, caused by normal and intended use of the equipment. This includes accidental instances resulting in a broken or cracked screen.

We will also cover malfunction of the device that arises naturally and through no fault of the user.

LOSSES WE WILL NOT COVER:

Intentional Acts: We will <u>not</u> cover loss or damage caused by your intentional damage or destruction of property covered under this policy. Intentional damage to the iPad is not covered and will result in the user being assessed the full value of the iPad and may result in discipline consistent with damaging of school property.

Corrosion & Rust: We will <u>not</u> cover loss or damage caused by or resulting from corrosion, rust or changes in humidity or temperature.

Dishonest Acts: We will <u>not</u> cover loss or damage caused by your dishonesty or anyone acting on your behalf. Nor do we cover any loss or damage arising from your illegal acts, whether committed alone or in collusion with others. However, if the loss or damage is caused by an act arising out of a pattern of criminal domestic violence and the perpetrator of the loss is criminally prosecuted for the act causing the loss, this exclusion does not apply to an otherwise covered loss suffered by another insured who did not cooperate in or contribute to the act that caused the loss.

Electrical Breakdown: We will **not** cover loss or damage to electrical equipment caused by electricity other than lightning. This includes damage arising from using charging materials that are not Apple certified.

Theft From An Unattended Vehicle: We will <u>not</u> cover loss or damage that is caused by or resulting from theft from an unattended vehicle except when it is securely locked, its windows are fully closed, and there is visible evidence that entry into the vehicle was forced.

Theft Without a Police Report: We will <u>not</u> cover loss or damage that is caused by or resulting from a theft without a police report being provided. We will also not cover any more than one theft per policy period.

Unexplained Loss: We will <u>not</u> cover loss or damage caused by your inability to locate an item of property unless a reasonable explanation as to what might have happened supports that the property was stolen. If your property was stolen, you are required to notify the local police immediately as well as the Auburn Public Schools within 72 hours of its disappearance. This policy does not provide coverage if you fail to notify the police.

What to Do if You Have a Loss

If you have a loss to property covered by this policy, you must:

- (1) notify the Auburn Police immediately upon discovery of the loss if the loss is a theft.
- (2) report the loss to school administration or to the technology department immediately. We will supply you with a Loss Report form, which you must complete.

What to Do if You Have Damage

If you have accidental damage to property covered by this policy, you must:

- (1) notify the school administration or technology department immediately.
- (2) complete an official APS iPad Damage Form, which will require a statement regarding how and when damage occurred.
- (3) do everything possible to protect the property from further damage.

General Rules and Conditions

These general rules and conditions apply to your policy:

CANCELLATION:

You may not cancel this policy. If you choose to purchase this optional insurance policy, you must keep the policy in place for the entire policy period. There are no refunds provided for students who withdraw from the Auburn Public Schools prior to the end of the school year.

YOUR COVERAGE:

Your coverage begins the day your payment is verified and will last either one full school year, or until the end of the current school year, as long as the specified terms and agreements have not been violated. See the insuring agreement for guidelines.

RENEWAL:

You may renew your policy annually at the start of the school year.
