

Duluth East High Dance Guest Registration

Harvest Ball / Sweetheart / Prom

(No guests allowed at other dances.)



EHS Students who wish to bring a guest not currently enrolled here must have their guest complete this form and return it on time, with all required signatures, to the EHS Principal's office. Any forms not in the high school office by the due date will be denied. All students MUST have this form filled out by the school administrator. *Only one visitor per East student is allowed.* Students in grade 9 and above may attend Fall Ball. Only juniors and seniors may attend Sweetheart and Prom. Sophomores may attend if invited by a junior or senior. No freshmen may attend prom.

Guidelines:

1. Visitors must have the form below completed and signed by their high school administrator and delivered to Mrs. Seboe, the EHS Principal, by the posted due date. It is the responsibility of the host student to inform their guest of the deadlines. **Forms are due to the office 5 school days before the dance.**
2. This form can be dropped off at the East Senior High office, faxed to Mrs. Seboe's office (218-336-8859), or scanned and emailed to danette.seboe@isd709.org. **Late or unsigned forms will not be accepted.**
3. Visitors must have a state or school photo ID to enter the dance and must arrive and leave with the EHS student.
4. Visitors must be 20 or under on the date of the dance and must be in good standing at their school. If you were removed from a dance within the past 6 months.
5. Each dance attendee (both the EHS student AND their guest) must have their parent/guardian sign this form prior to giving it to their high school principal to sign. You are signing to indicate that you understand all rules and will abide by them. EHS administration has the sole discretion of accepting or denying any guest.
6. **Visitors must abide by all rules and guidelines for EHS dances, including the following;**
 - a. **Students are not allowed to leave the dance and return later.**
 - b. **Students will respect and be courteous to all staff and fellow students.**
 - c. **Students cannot be under the influence of chemicals and/or alcohol. Any student suspected of being under the influence will be denied entrance or removed from the dance. Dances are chemical and tobacco free. Any student in possession of alcohol, tobacco, or other chemicals will be escorted out of the dance and may be referred to the Officer on Duty.**
 - d. **Law enforcement is present at dances and students suspected or found to be in violation will be referred to law enforcement immediately.**
 - e. **Dancing must be school appropriate. Dancing front to back in a circle is acceptable provided that there is visible space between the couple, both remain upright, hands remain in appropriate places, and dancing is not repetitively explicit.**
 - f. **All school policies and rules apply during dances.**
