BUSINESS ADMINISTRATOR'S REPORT  
April 19, 2018

Forecast – The preliminary expense forecast for 2017-2018 shows a positive balance of \$418,557. The bulk of the savings is the change in personnel and benefits in Regular and Special Education, health insurance was budgeted at a guaranteed maximum of 8% and actually came in at 4.5% for a savings of approximately \$190,000.

School Administration and Facilities are positive as we have new School Administrators and our fuel oil cost are estimated to be under by about \$67,000. This positive balance changed from the previous month's estimate by \$26,400 as I have started to lower the expected amount to be spent on supplies and anticipate no more expenditures for textbooks, furniture, equipment, etc. I am still leaving money in the software lines as the Technology Coaches are still evaluating the software purchases and it is taking some time for them to review them all.

The forecast might continue to change as the year progresses. Changes in placements and to IEP's throughout the year could lead to increased or reduced special education costs. Not included in this estimate is the possibility of an elementary student being placed out of district, which will affect the last two months of this year and following school years.

The Revenue forecast is showing a negative \$196,966. This is due to \$107,681 less Catastrophic Aid (now referred to as Special Education Aid by the Department of Education), \$53,664 less in Adequacy (per the State estimate at this time), \$75,777 shortfall in Medicaid revenue as our special education costs are down, \$22,406 additional tuition revenue from students attending from other towns.
