

Iron Academy Bus Information and Release

We are excited to announce a daily bus route for Iron Academy students! We are offering this service at an additional fee to cover costs, with the first rider at \$75 per month, and each additional sibling at \$25. You may sign up on a monthly basis. At this time, we do not have a “per ride” fee. Students must be on the bus at the departure time to ride.

Stops will be at the following locations:

Morning Departures

- First Watch restaurant at 7:00 am. (6320 Capital Blvd., Ste. 130)
- The Fountain Church at 7:15 am. (9621 Six Forks Rd.) ****Should your son miss the bus in the morning it will be the parent’s responsibility to make sure he arrives at school by 7:45 am.**

Afternoon Drop-offs (times may be subject to change)

- Burger King and Taco Bell parking lot on Six forks at 3:55 – 4:05
- Best Buy and McDonalds parking lot on Capital at 4:10 – 4:20 ***Both locations are just off I-540*

The bus will leave school at 3:30 pm. It is your student’s responsibility to get on the bus! Each student will select a primary drop off location for the year. If you need to change the location of your stop for a particular day or ongoing, please email this information to busdrivercontacts@ironacademy.org before 3:00 p.m.. Please be sure your student knows as well. By signing the attached waiver, you are agreeing to meet your student at the assigned drop-off location when the bus drops off or allowing your student(s) to wait unattended until you arrive. The bus will not be staying with the students until parents arrive.

Students are expected to behave as gentlemen on the bus. Inappropriate or unsafe behavior will not be tolerated. In addition, we expect our students to represent Iron Academy well while waiting for parents at drop off locations. Failure to do so will result in immediate loss of bus privileges.

Please return this form no later than August 20th to reserve your spot on the bus. Late applications may not be accepted due to space restrictions. Thank you.
