Dear Littleton Families,

We realize that these are incredibly difficult times for all of us throughout our nation as our country makes every attempt to “flatten the curve” of COVID-19 and slow its spread. Family and work-life for most of us has changed dramatically. Our daily dynamic has been upended in ways we never could have imagined. It all feels surreal and unsettling.

As we move forward we continue to recognize the need for flexibility in everything that we do. Guidelines continue to change, and we must adapt daily.

This week we implemented our second phase of providing enrichment opportunities by grade span. During the week many staff have jumped in and offered additional enrichment resources to their students and have also connected with their classes. Staying connected to each other is so important during this time and is something that we will continue to do as we reflect and evaluate how to best meet the needs of our students.

On Monday, March 30th, we will begin our third phase of enrichment resource implementation, which will involve our staff providing enrichment opportunities that are tailored to the grade and course level. These enrichment activities will be found on the [LPS Optional Enrichment site](#). Our staff have worked hard to provide a variety of opportunities for our students that include technology and non-technology based options while incorporating student choice. At this time students will not be assessed, however, teachers will provide feedback to students in order to maintain the academic connection. As per guidance from the Department of Elementary and Secondary Education, these enrichment activities will continue to be optional.

As per the Governor’s press conference today, schools will remain closed until May 4, 2020.

We continue to have ongoing conversations with the State Commissioner of Education specific to providing additional guidance as a result of the extended school closure. Our district leadership has begun and will continue discussions specific to how this will affect Littleton
