- I understand that it is not possible to predict all possible side effects or complications associated with receiving vaccine s . I understand the risks and benefits associated with the above vaccine and have received, read and/or had explained to me the Emergency Use Authorization Fact Sheet on the COVID-19 vaccine I have elected to receive. I also acknowledge that I have had a chance to ask questions and that such questions were answered to my satisfaction.
- I acknowledge that I have been advised to remain near the vaccination location for approximately 15 minutes after administration for observation and to call 9-1-1 if I experience a severe reaction at any time after leaving the vaccination location.
- On behalf of myself, my heirs and personal representatives, I hereby release and hold harmless PCHG and their staff, agents, successors, divisions, affiliates, subsidiaries, officers, directors, contractors and employees from any and all liabilities or claims whether known or unknown arising out of, in connection with, or in any way related to the administration of the vaccine listed above.
- I acknowledge that: a I understand the purposes/benefits of Florida SHOTS, Florida's immunization registry and b DOH will include my personal immunization information in Florida SHOTS and my personal immunization information will be shared with the Centers for Disease Control CDC or other federal agencies.
- I further authorize PCHG or its agents to submit a claim to my insurance provider or Medicare Part B without supplemental coverage payment for me for the above requested items and services.
