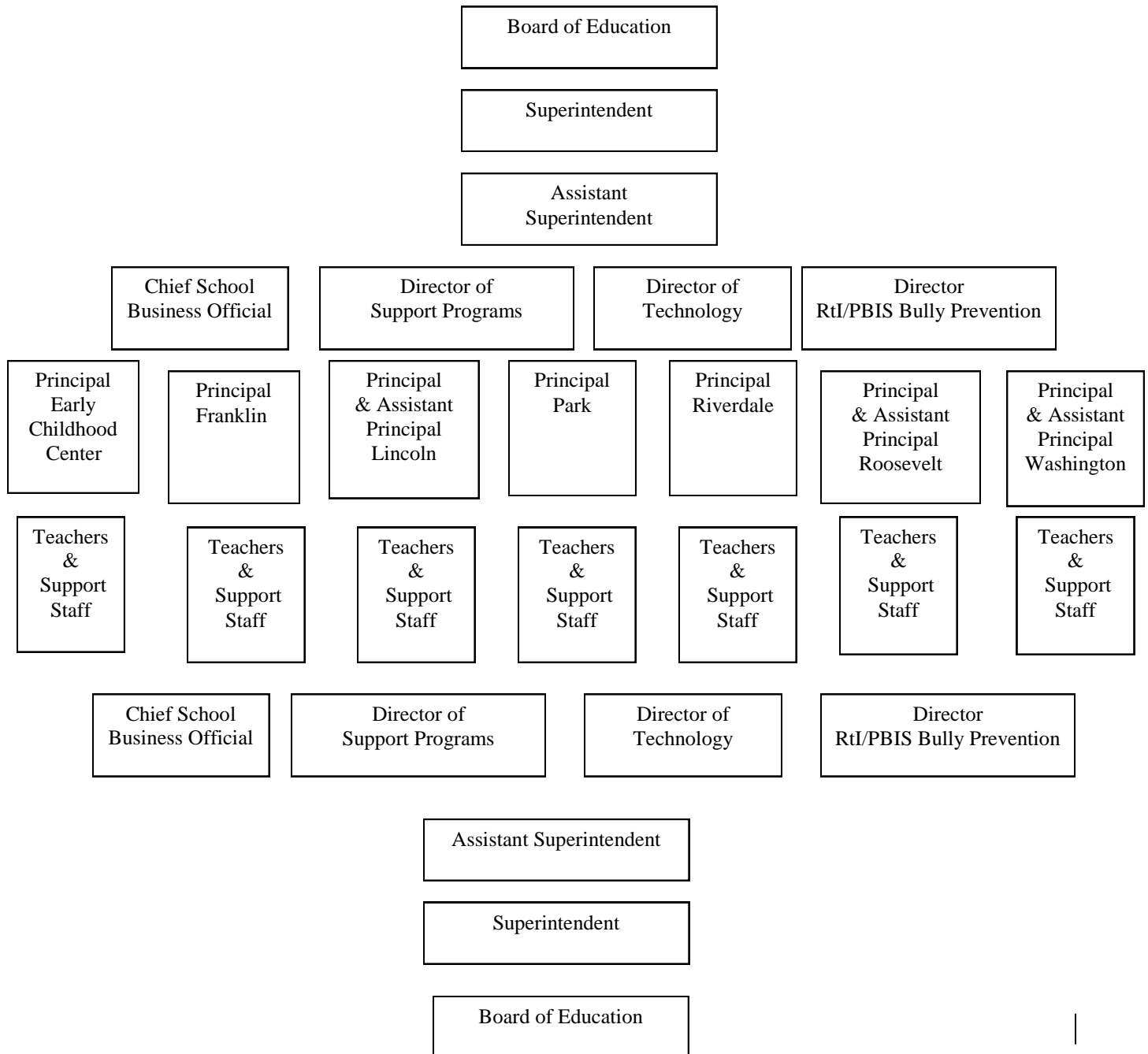

RESOLUTION NO. 01272011

A RESOLUTION AMENDING RESOLUTION NO. 01282010 TO SET FORTH THE PROCESS FOR DESIGNATING THE SCHOOL DISTRICT'S FREEDOM OF INFORMATION ACT OFFICERS AND THOSE WHO WILL RECEIVE OPEN MEETINGS ACT TRAINING

WHEREAS, Dolton Riverdale School District No. 148 ("School District"), Cook County, Illinois, is a School District operating under and pursuant to the Illinois School Code; and

WHEREAS, the School District, through its duly elected School Board, previously approved Resolution No. 01282010 that adopted policies regarding the Freedom of Information Act and the Open Meetings Act and that designated the School District's Freedom of Information Act Officers and those who will receive Open Meetings Act training;

WHEREAS, the School District desires to amend Resolution No. 01282010 to modify the procedure for designating the School District's Freedom of Information Act Officers and those who will receive Open Meetings Act training.

NOW, THEREFORE, BE IT RESOLVED BY THE School Board of Dolton Riverdale School District No. 148, Cook County, Illinois, as follows:

Section 1. The above stated recitals are incorporated herein by reference.

Section 2. Section 4 of Resolution No. 01282010 is hereby deleted in its entirety and replaced as follows:

The School Board shall designate individuals to serve as Freedom of Information Officers and shall designate individuals to take the Open Meetings Act training as required by both the Freedom of Information Act and the Open Meetings Act. The School Board shall ensure that sufficient officers are designated to handle FOIA requests and shall also ensure sufficient individuals are named to take the required trainings under the Open Meetings Act. The School Board shall review the designations on an annual basis unless new designations or other actions are required prior to the annual review. All designations shall be recorded in the minutes, submitted to the Attorney General's office as required by law and shall be posted on the School District's website as required by law.

Section 3: In the event a conflict exists between the terms of this Resolution and any other resolution of the School District, the terms of this Resolution shall govern.

Section 4: In the event that any term or provision hereof is found or determined to be invalid, the invalid portion shall be deemed stricken here from and the remainder shall be in full force and effect.

Section 10: This Resolution shall be in full force and effect immediately after its passage and approval.
