	Official Documented Meeting Minutes: The excavation for the septic tank has been dug. Temp fence has been installed around the hole to help prevent unauthorized access. The tank will be set tomorrow and the sewer pipe work will take place next week. There were no other safety or logistics concerns.

	Official Documented Meeting Minutes: Mike noted that the septic tank work has started and the tank will be set tomorrow followed by the sewer line work next week. Wickson and Stellos are working on site lighting at the phase 2 parking lot. Wickson has created the additional detention pond area per the revised C-3 drawing. Final cleaning is ongoing in the addition and will be completed next week. The roofers installed the gravel stop on the roof edge perimeter this week. Control joint sealant work started today. ECCI will be hiring Streamline Waterproofing to install the exterior expansion joint material. Work in the boiler room is wrapping up and test and balance of the HVAC system will take place next week. Alan will turn on the existing building A/C on Monday to allow for actual conditions with the doors between the addition and existing school. This will allow for a more accurate test and balance. ECCI is on-target for final inspections and substantial completion of the addition for the end of July pending successful septic inspections. The septic permit from the NHDES was provided to the civil engineer on Monday 7/8/19. The gym painting is complete. The wall infill at the former folding tables is complete. Gym floor abatement and demo is scheduled to start on or about 7.22.19. Jon has requested an update on ETA of the lockers and wall pads from the subcontractor. The new cafeteria demo is complete. Painting is ongoing and will be done by tomorrow (Friday). Ceilings are scheduled in the cafeteria for next week. ECCI is installing new siding at the gable end of the cafe now. The new cafeteria and kitchen windows are scheduled for delivery the week of 8/12/19. The area of refuge opening masonry widening is complete and wall painting will take place soon at this area. ECCI will start the punch list process with LBPA around the time of the next meeting. Room signage for the addition has been ordered and should be installed during August.

	Official Documented Meeting Minutes: Mike brought up the issue of the grade at the top of the new septic tank. The top of tank is at grade 70 per the design. Finish floor for the building is at 72. ECCI will need to have Wickson build up a berm at the top of the tank to provide as close to 1' of cover as possible. If needed, the addition of two (2) bollards to prevent driving onto the tank will be evaluated after the grading work is complete.

	Official Documented Meeting Minutes: Two issues were observed during the walkthrough of the new cafe area. Marc asked if the block end wall that demises the existing hallway from the new cafe needs to be extended to deck. As this is a smoke wall ECCI will have the drywall sub frame and drywall an upper wall extension from the top of existing block wall to the underside of the roof. Marc also asked if the main ERV trunk duct needs to be wrapped as it is in an unconditioned space above the insulated ACT. ECCI will have Oliver ask their design engineer. ECCI will also install batt insulation in the wood stud gable end wall at the Cafe to help with this issue.
