IF YOU ARE AGE 65 OR OLDER, PLEASE NOTE THAT WE DO OFFER THE SUPPLEMENTAL PLAN, MEDICOMP 3, WITH OR WITHOUT THE RX SERVICE. HOWEVER, SHOULD YOU CHOOSE TO ENROLL IN THE PLAN W/O THE RX SERVICE AND WANT TO CHANGE BACK TO THE RX SERVICE PLAN IN THE FUTURE, YOU MUST HAVE BEEN ENROLLED IN PART D OF MEDICARE & CHANGE BACK TO THE PLAN W/RX SERVICE WITHIN 24 MONTHS. IF YOU ARE INTERESTED IN THIS PLAN, WITHOUT THE RX SERVICE, PLEASE CONTACT ME BY JUNE 1ST.
