**ARTICLE 1**

**Operating Budget**

Shall the School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$28,770,668? Should this article be defeated, the default budget shall be \$28,979,335 which is the same as last year, with certain adjustments required by previous action of the School District or by law, or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (Majority vote required.)

*Note: Warrant Article #1 (operating budget) does not include appropriations in any other warrant articles.*

**ARTICLE 2**

**HVAC Upgrades**

To see if the School District will vote to raise and appropriate the sum of 325,000 to continue the HVAC replacement project at Winnacunnet High School? This appropriation will be used to upgrade the HVAC systems at the Technology Education Building. This project is part of the facility plan adopted by the school board. This will be a non-lapsing appropriation per RSA 32:7 VI and will not lapse until the project is complete or June 30, 2024, whichever is earlier. (Majority vote required.)
