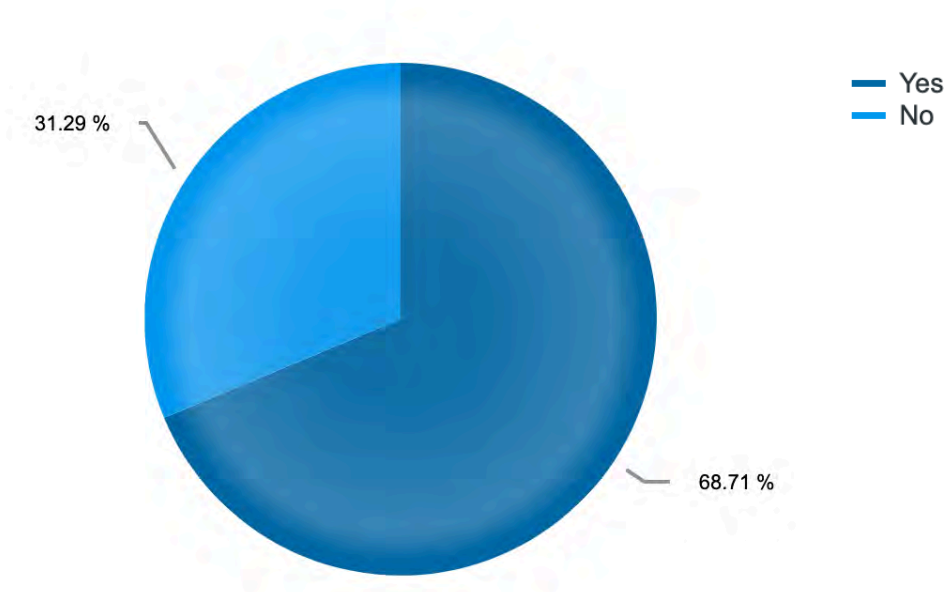
## Findings of Surveys

The following responses were received over a two week period.

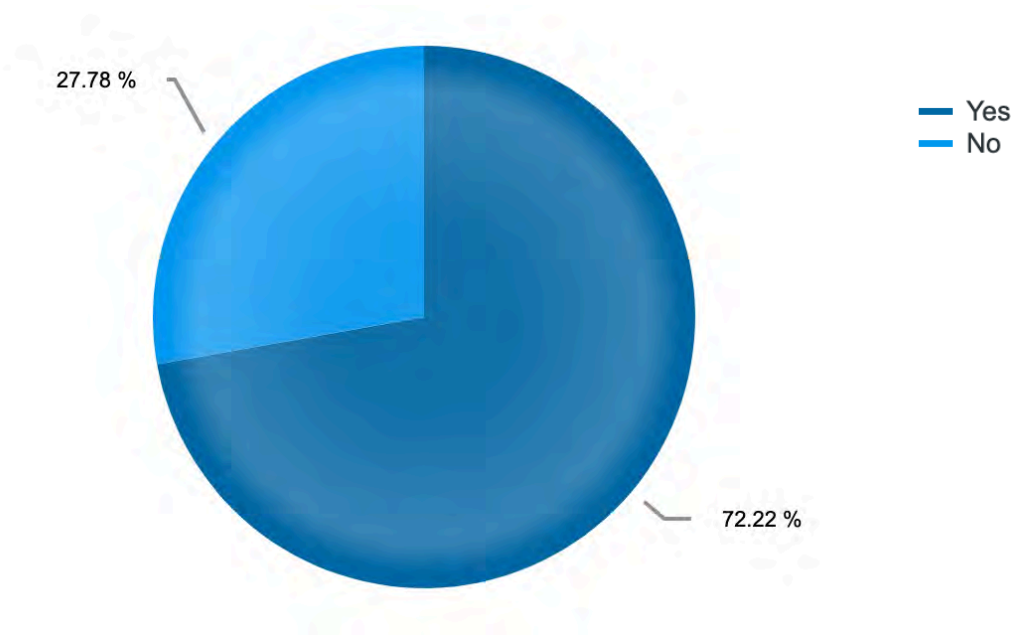


## Faculty & Staff Survey

The following responses were received over a two week period.



Both surveys indicated the consistency that the majority of the school community is supporting In-person classes to start the 2020-2021 school year.
