# ORDINANCE NO. 19-4

AN ORDINANCE MERGING FISHHAWK COMMUNITY DEVELOPMENT DISTRICT, FISHHAWK COMMUNITY DEVELOPMENT DISTRICT II AND **FISHHAWK** COMMUNITY **DEVELOPMENT** DISTRICT Ш **AND** ESTABLISHING THE FISHHAWK RANCH COMMUNITY DEVELOPMENT DISTRICT PURSUANT TO CHAPTER 190, FLORIDA STATUTES; SPECIFYING GENERAL AND SPECIAL POWERS OF THE DISTRICT; DESCRIBING THE BOUNDARIES OF THE DISTRICT; NAMING THE MEMBERS OF THE BOARD OF SUPERVISORS; PROVIDING FOR THE ADMINISTRATION AND FINANCING OF THE DISTRICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Fishhawk Community Development District, Fishhawk Community Development District III, and Fishhawk Community Development District III ("Petitioners") have filed a Petition with Hillsborough County requesting that the Board of County Commissioners of Hillsborough County ("County") adopt an ordinance merging the Petitioners into one district and establishing the Fishhawk Ranch Community Development District pursuant to Chapter 190, Florida Statutes (the "Merged District"), and designating the real property described in Exhibit "A", attached hereto, as the area of land for which the Merged District is authorized to manage and finance basic service delivery; and

WHEREAS, the Petitioners have taken all actions required by Chapter 190, Florida Statutes as conditions precedent to a merger of their Districts into one resultant Merged District; and

WHEREAS, the County has held a public hearing on the Petition in accordance with the requirements and procedures of Section 190.005(1)(d) and 2(b), and 190.046(3) and (4) Florida Statutes; and

WHEREAS, upon the consideration of the record established at that hearing and the factors set out in Section 190.005(1)(e), Florida Statutes, the County determined that the Merged District will constitute a timely, efficient, effective, responsive and economic way to deliver community development services in the area described by the Petition.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HILLSBOROUGH COUNTY, FLORIDA, THIS <u>9TH</u> DAY OF APRIL , 2019, AS FOLLOWS:

# **SECTION 1. FINDINGS OF FACT.** The County hereby finds and states that:

- 1. The "WHEREAS" clauses stated above are adopted as finding of fact in support of this Ordinance;
- 2. All statements contained in the Petition are true and correct;
- 3. The establishment of the Merged District is not inconsistent with any applicable element or portion of the State Comprehensive Plan or the County's Comprehensive Plan;
- 4. The area of land within the proposed Merged District is of sufficient size, is sufficiently compact and is sufficiently contiguous to be developable as one functional interrelated community;

- 5. The creation of the Merged District is the best alternative available for delivering community development services and facilities to the area that will be served by the District;
- 6. The proposed community development services and facilities to be provided by the Merged District will not be incompatible with the capacity and uses of existing local and regional community development services and facilities; and
- 7. The area that will be served by the Merged District is amenable to separate, special district government.

# SECTION 2. CONCLUSIONS OF LAW.

- 1. This proceeding is governed by Chapter 190, Florida Statutes;
- 2. The County has jurisdiction pursuant to Section 190.005(2) and 190.046(4), Florida Statutes; and
- 3. The granting of the Petition complies with the requirements of Chapter 190, Florida Statutes.

**SECTION 3. NAMING OF THE DISTRICT.** There is hereby created a community development district situated entirely within unincorporated Hillsborough County, Florida, which shall be known as the "Fishhawk Ranch Community Development District."

**SECTION 4.** <u>CREATION AND BOUNDARIES.</u> The external boundaries of the Merged District are described in Exhibit "A" attached hereto, the overall parcel containing 2,562.81 acres, more or less.

**SECTION 5.** <u>INITIAL BOARD.</u> The following five persons are designated as the initial members of the Board of Supervisors of the Merged District consistent with the requirements of Chapter 190.046 Florida Statutes:

Terrie Morrison – Fishhawk Community Development District Resident Robert Kneusel - Fishhawk Community Development District II Resident Thomas Avino - Fishhawk Community Development District III Resident Kerri McDougald – At Large (Fishhawk Community Development District Resident) Ruth Brown - At Large (Fishhawk Community Development District II Resident)

**SECTION 6.** <u>CHARTER.</u> The Merged District shall be governed by the provisions of Chapter 190, Florida Statutes, as amended, including Sections 190.006 - 190.041, Florida Statutes. Consent is hereby given to the Merged District's Board of Supervisors to exercise of the powers set forth in Section 190.011 AND Sections 190.012(1), (2)(a), (b), (d), (e) and (f), and (3) of Chapter 190, Florida Statutes, as amended.

**SECTION 7. EFFECTIVE DATE**. This Ordinance shall be effective immediately upon receipt of acknowledgment that a copy of this Ordinance has been filed with the Secretary of State.

**SECTION 8. SEVERABILITY.** If any section, subsection, sentence, clause, provision, or other part of this Ordinance is held invalid for any reason, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.
