Notice is hereby given that the Board of Supervisors (“**Board**”) of the Wesbridge Community Development District (“**District**”) will hold a special meeting of the Board of Supervisors on May 11, 2020 at 5:00 p.m. to be conducted by telephonic or video conferencing communications media technology pursuant to Executive Orders 20-52 and 20-69 issued by Governor DeSantis on March 9, 2020, and March 20, 2020, respectively, and pursuant to Section 120.54(5)(b)2., Florida Statutes.
