Summary, Asturian Pkwy., Promenade Pkwy. Eastbound

General Updates, Recent & Upcoming Maintenance Events, Important Notices:

□ Unless there is a need by Down To Earth to utilize the potable water whips in the parks at the intersection of Trails Edge, Aviles & Renaissance, I would suggest placing a lock on the latch to prevent unauthorized use. Currently, the whip in the park on the south side of Trails Edge is dripping and has a male garden hose adaptor on the end. (See Pic and below)



The following are action items for Down to Earth to complete. Please refer to the item # in your response listing action already taken or anticipated time of completion. Red text indicates deficient from previous report. Bold Red text indicates deficient for more than a month. Green text indicates a proposal has been requested. Blue indicates irrigation. Orange indicates an issue to be handled by Staff and Bold, underlined black indicates an update or question for the BOS.

- I've never been a proponent of cutting things down in an effort to control weeds as has been done to the Liriope on the Asturian Parkway medians. These weeds should've been hand pulled and should've never been allowed to get as large as they were.
- Make sure a clean straight line is maintained between the annual bed and the Dwarf Asian Jasmine bed at the tip of the Asturian Parkway median at Promenade Parkway (PP). In fact, anywhere there is Confederate or Dwarf Asian Jasmine, these plant beds need to be defined from all others. Weeds are starting in the annual bed.
- The Dw. Asian Jasmine on the south side of PP at Gathering Way has clearly had an issue with grassy weeds in the past as they are reemerging. These need to be completely

- eradicated and a 1"-2" layer of pine fines would help with the aesthetics of this bed.
- 4. The bed underneath the Crape Myrtles on the north side of PP at Stone Table is fully loaded with weeds. Do not cut Liriope. (Pic 4)




Lantower Asturia, Promenade Pkwy., Caravan Park

- Crapes near the entrance to Lantower Asturia must always be trimmed so they do not block any street signs, especially Pedestrian Crossing signs.
- Liriope beds on the Lantower Asturia side of the sidewalk along the south side of PP are also weedy.
- 7. Make sure there is a clear delineation between the edge of the turf and the outer edge of the Dwarf Asian Jasmine bed at the east SR 54 entrance around the sign monument. Additional fertilizations may help to get this Jasmine bed thicker and fuller. Eradicate weeds here also.
- Inspect a bare patch of turf (app. 5' x 8') on the south side of PP near the Lantower entrance for chinch bug. Treat accordingly. This is in the vicinity of a very low-hanging Oak. Lift.
- 9. The response to June 10th's report (#14) for the vines and weeds in the buffer leading up to the clubhouse from the east (Claymore) was "to be completed". In these responses, we need to have dates provided as to when the task will be completed. This buffer is still weedy, and vines are over the Hollies. (Pic 9)
- 9

- 10. In the east lawn of the clubhouse, lift an Oak near Natchez Crape Myrtles.
- 11. In the plant beds on the west side of Caravan Park, there are four to five dead Walter's Viburnum that need to be replaced. Are these still under warranty with the installing contractor? Weeds in these two areas, and throughout the park, in general, need to be eradicated. (Pic 11)



12. In the Caravan Park, there are also two dead trees. If these are still under warranty with the installing contractor, we will need to have them replace them. If they are not, I will have D2E provide a proposal in the proposal section of the report. (Pic 12)





Caravan Park, Park "R", Caravan Median

13. Also in Caravan Park, in my opinion, there are a few trees that should have been restraightened and staked once they began to lean. These trees have probably not sent out enough anchor roots to prevent them from being re-straightened and re-staked now. However, it might be necessary to perform some minor root pruning on the obtuse angled side of the lean. This is to generate new anchor roots. Replace straps. (Pic 13)



- 14. Hurricane blowers should not be used along mulch beds adjacent to asphalt or sidewalks.
 This appears to be blowing the outer 12" 18" of mulch back into the bed leaving exposed soil at the curb line.
- 15. In the pocket park "Q", there are two dead Podocarpus that need to be replaced under warranty, if they are still under warranty. If they are not, I will have D2E Install and Invoice replacements. (Pic 15>)
- 16. Hand remove dieback in some of the Walter's Viburnum in Park "R" as well as the sprayed, dead grassy weeds in the beds.
- 17. Both Parks "Z" & "Z1", in general, just need to be cleaned up ... landscape debris removed, dead growth trimmed out, etc. (Pic 17>)
- 18. Treat all active fire ant mounds in Caravan Ave. median. Once mounds are dead, return

to rake out soil to re-expose turf or mulch.

19. Mowers need to mow the Zoysia more evenly, and at a slightly lower height, in the Caravan median. (Pic 19)









Portico, Trails Edge, Long Bow

- 20. We need to make sure all beds of Dwarf Asian Jasmine, Confederate Jasmine, etc., are being kept from encroaching into adjacent beds of plants. A clean bare strip 8"- 10" wide needs to be maintained clear.
- 21. Tree Ligustrums along the trail at the turn from Promenade to Portico still need to be trimmed.
- 22. Remove grassy weeds from around the Knockout Roses in the same area as above.
- 23. Crews need to remove more dead Muhly Grass (and other ornamental grasses) clippings after trimming is completed. Specifically at the Trails Edge Blvd. cul-desac.
- 24. Remove tall weeds from the beds along the side yard of the last house on the left at the Trails Edge cul-de-sac. Lift trees in the same area, particularly on the house side of the buffer. (see below)



- 25. The Brazilian Pepper (Item 18, June) located within a Holly tree along the aluminum fencing behind the first home on the left on Edge Ct. cul-de-sac is still there. This should be cut to within 12" of the ground and the stump should be carefully coated with Garlon to kill it. DO NOT GET THIS CHEMICAL ON THE HOLLY! (Pic 25>)
- 26. In this same yard, I was informed there are two yard-drains extending from this same resident out into the lawn. These are no longer visible and need to be cleared.

27. Dwarf Firebush need to be kept off the sidewalk leading to the bench in the little park on the west side at the end of Long Bow Way. (Pic 27)



- 28. Also at the end of Long Bow Way, there is a Pine tree dying. As a preventative, I recommend an injection or root drenching of a product that will control pine beetles on the surrounding Pines. This should be applied before any removal of the dead Pine which I will request in the proposal section.
- 29. Remove weeds from the curb inlet on the east side of the Long Bow Way adjacent to the pond.
- 30. Make sure wetland growth on the east side of the trail between Long Bow and Verona is not creeping into the mowed turf area. (Pic 30>)





Trail Between Long Bow and Verona, Trails Edge & Aviles

31. Along the same trail as in Item 30, relocate a drip line adjacent to the trail to a spot where it will be closer to the plants. (Pic 31)



32. The Loropetalum on the north side of Trails Edge approaching Aviles Pkwy. is failing, most than likely due to the use of reclaimed water. Loropetalum hates any kind of salt and reclaimed water is notoriously full of salts. I will work with D2E to replace this plant with a more suitable choice. I have asked D2E to not proceed with a drenching of lime and sulfur, originally requested last month. (Pic 32>)



33. Hopefully, debris thrown over the fence from a resident into the small park on the south side of Trails Edge is a temporary thing. This is the same park and lawn with the male hose adaptor on a potable water whip mentioned in the summary at the start of the report. (Pic 33>)

- 34. Eradicate turf and bed weeds in the same park as in Item 33.
- 35. Mowers and mow patterns should be altered to avoid the "hill-valley-hill" patterns which form in ROW's This typically leads to the "hill" portion becoming scalped and then weeds filling in. This pattern exists at least on the south ROW of Aviles between Satilla Loop and Sevares Ct. and other locations. (Pic 35>)

36. What is to become of a large debris pile at the start of the trail north of Aviles west of Sevares? Last month's response said "Complete". It is still there. (Pic 36>)



37. Eradicate weeds in the park along Aviles past Sevares.





Clubhouse & Park Northward

38. Item 25 in June's report referred to the rough looking turf in the square park north of the main recreation center. The response was irrigation runtimes were increased. However, I didn't feel it was drought related. It looks more like fungal or insect damage. (Pic 38>)





- 39. Podocarpus at the clubhouse pool pump area and dog park needs to be trimmed. (Pic 39>)
- 40. Are turf weeds being treated in the front lawn of the club? There seem to be as many as last month.
- 41. Palms were trimmed on the pool deck; however, palm beds need to be weeded and palm saplings need to be removed.

 (Pic 41 >>)





- 42. There is also Torpedograss and dollar weed in the open lawn behind the pool.
- 43. Grass clippings are being blown into mulch beds as well as left n piles in turf areas.





Clubhouse

These duff piles need to be re-distributed into the lawn and not blown into mulch beds or residential lawns. Mulch is too expensive to cover up. (Pics 43a and 43b)



44. Make sure dead growth is always being removed from the African Iris between the gym and the clubhouse.






Proposals

- D2E to provide a proposal to fill in the bare spots in the Dwarf Asian Jasmine bed on the SE corner of the intersection of Promenade and Asturian. Use 1 Gal., FULL plants, app. 18" centers.
- In conjunction with Item 12, if these trees in Caravan Park are not under warranty, D2E to provide a proposal to replace each tree with like size and species. I believe one is a Crape Myrtle and the other is a Holly.
- If the dead Podocarpus mentioned in Item 15 are no longer under warranty, D2E to provide a proposal to replace with two (2) 7 Gal., FULL Podocarpus.
- 4. At the end of Long Bow Way, there is a dying Pine tree. D2E to provide a proposal to flush cut this tree. However, I also request another proposal to apply a root drench or an injection to eradicate pine beetles on surrounding Pines. This drenching should take place prior to the removal of the dead Pine as stress on Pines attract other beetles. (Pic 4)



5. D2E to provide a proposal to install enough Dwarf Asian Jasmine on the east side of the trail south of Long Bow on the way top Verona Lane. Use 1 Gal., FULL plants on 18" centers. Ensure proper irrigation is present or add more and include in proposal (Pic 5 and >)

RE: Amendments to Section 189.069(2)(a), *Florida Statutes*

The Florida Legislature recently enacted amendments to the website requirements contained in Section 189.069(2)(a), *Florida Statues*, effective July 1, 2020. The full text of these amendments is attached to this memorandum as **Exhibit A**, and the amendments are summarized below:

- The requirement to post the final, complete audit report for the most recent completed fiscal year and audit reports required by law or authorized by the governing body of the special district may be satisfied by providing a link to the audit report on the Auditor General's website.
- The public facilities report is no longer required to be posted.
- Meeting materials accompanying meeting or workshop agendas are no longer required to be posted. Please note that the agenda itself is still required to be posted.

The amendments do not prevent districts from including these documents on their websites, but districts may remove them if they so choose. We recommend requesting board direction on a district-by-district basis.

CHAPTER 2020-77

Committee Substitute for Senate Bill No. 1466

An act relating to government accountability; amending s. 189.031, F.S.; specifying conditions under which board members and public employees of special districts do not abuse their public positions; amending s. 189.069, F.S.; revising the list of items required to be included on the websites of special districts; amending s. 190.007, F.S.; specifying conditions under which board members and public employees of community development districts do not abuse their public positions; providing effective dates.

Be It Enacted by the Legislature of the State of Florida:

- Section 1. Effective January 1, 2021, subsection (6) is added to section 189.031, Florida Statutes, to read:
- 189.031 Legislative intent for the creation of independent special districts; special act prohibitions; model elements and other requirements; local general-purpose government/Governor and Cabinet creation authorizations.—
- (6) GOVERNANCE.—For purposes of s. 8(h)(2), Art. II of the State Constitution, a board member or a public employee of a special district does not abuse his or her public position if the board member or public employee commits an act or omission that is authorized under s. 112.313(7), (12), (15), or (16) or s. 112.3143(3)(b), and an abuse of a board member's position does not include any act or omission in connection with a vote when the board member has followed the procedures required by s. 112.3143.
- Section 2. Paragraph (a) of subsection (2) of section 189.069, Florida Statutes, is amended to read:
- 189.069 Special districts; required reporting of information; web-based public access.—
- (2)(a) A special district shall post the following information, at a minimum, on the district's official website:
 - 1. The full legal name of the special district.
 - 2. The public purpose of the special district.
- 3. The name, official address, official e-mail address, and, if applicable, term and appointing authority for each member of the governing body of the special district.
 - 4. The fiscal year of the special district.

- 5. The full text of the special district's charter, the date of establishment, the establishing entity, and the statute or statutes under which the special district operates, if different from the statute or statutes under which the special district was established. Community development districts may reference chapter 190 as the uniform charter but must include information relating to any grant of special powers.
- 6. The mailing address, e-mail address, telephone number, and website uniform resource locator of the special district.
- 7. A description of the boundaries or service area of, and the services provided by, the special district.
- 8. A listing of all taxes, fees, assessments, or charges imposed and collected by the special district, including the rates or amounts for the fiscal year and the statutory authority for the levy of the tax, fee, assessment, or charge. For purposes of this subparagraph, charges do not include patient charges by a hospital or other health care provider.
- 9. The primary contact information for the special district for purposes of communication from the department.
- 10. A code of ethics adopted by the special district, if applicable, and a hyperlink to generally applicable ethics provisions.
- 11. The budget of the special district and any amendments thereto in accordance with s. 189.016.
- 12. The final, complete audit report for the most recent completed fiscal year and audit reports required by law or authorized by the governing body of the special district. If the special district has submitted its most recent final, complete audit report to the Auditor General, this requirement may be satisfied by providing a link to the audit report on the Auditor General's website.
- 13. A listing of its regularly scheduled public meetings as required by s. 189.015(1).
 - 14. The public facilities report, if applicable.
- 15. The link to the Department of Financial Services' website as set forth in s. 218.32(1)(g).
- <u>15.16.</u> At least 7 days before each meeting or workshop, the agenda of the event, along with any meeting materials available in an electronic format, excluding confidential and exempt information. The information must remain on the website for at least 1 year after the event.
- Section 3. Effective January 1, 2021, subsection (1) of section 190.007, Florida Statutes, is amended to read:

190.007 Board of supervisors; general duties.—

(1) The board shall employ, and fix the compensation of, a district manager. The district manager shall have charge and supervision of the works of the district and shall be responsible for preserving and maintaining any improvement or facility constructed or erected pursuant to the provisions of this act, for maintaining and operating the equipment owned by the district, and for performing such other duties as may be prescribed by the board. It shall not be a conflict of interest under chapter 112 for a board member or the district manager or another employee of the district to be a stockholder, officer, or employee of a landowner or of an entity affiliated with a landowner. The district manager may hire or otherwise employ and terminate the employment of such other persons, including, without limitation, professional, supervisory, and clerical employees, as may be necessary and authorized by the board. The compensation and other conditions of employment of the officers and employees of the district shall be as provided by the board. For purposes of s. 8(h)(2), Art. II of the State Constitution, a board member or a public employee of a district does not abuse his or her public position if the board member or public employee commits an act or omission that is authorized under this subsection, s. 112.313(7), (12), (15), or (16), or s. 112.3143(3)(b), and an abuse of a board member's public position does not include any act or omission in connection with a vote when the board member has followed the procedures required by s. 112.3143.

Section 4. Except as otherwise expressly provided in this act, this act shall take effect July 1, 2020.
