Summary/Hidden Creek Blvd

General Updates, Recent & Upcoming Maintenance Events.

- Overall, the property requires extensive weeding and plant bed detailing. The current condition is unacceptable and must be addressed promptly to meet maintenance standards.
- Please continue edging the beds to maintain defined boundaries before they become overgrown.

The following are action items for Juniper Landscaping to complete. Please refer to the item # in your response listing action already taken or anticipated time of completion. **Red text** indicates deficient from previous report. **Bold Red text** indicates deficient for more than a month. **Green text** indicates a proposal has been requested. **Blue** indicates irrigation. **Orange** text represents Staff and **bold, black, underlined** represents questions or information for the BOS.

1. Palm trees in entrance median bed have still not been trimmed. Is this on the schedule? The entrance should look neat and tidy at all times.(pic.1)



5. Several Duranta 'Gold Mound' and Jasmine shrubs have either died or are dying back in the center median. The die back in shrubs should be trimmed back and dead shrubs removed completely.(pic.5a>>,5b>>,5c>>)



2. Application placards are present in median with a date of November 3rd. No weed dieback is present. Do we have records of what was done?(Pic 2>)

3. **Turf on the endcap of the entrance median is now established inside the bed. This needs to be hard edged to reestablish bed line and all turf and weeds inside the bed must be sprayed and then hand pulled. This has been in multiple reports.(Pic 3>)**

6. Bed weeds are present in all areas throughout property. High visibility areas such as entrance beds and beds around mailbox area need to be kept as weed free as possible. (pic. 6a, 6b, 6c)

7. Monument Sign beds must be kept neat and tidy at all times. Beds must be hard edged at every mow event and weeds sprayed/pulled and at every detail event.(pic.7a,7b,7c)



8. All storm grates should be hard edged to prevent grasses and debris from over taking area and prevent clogging.(pic.8)



9. Skirting bed around pump station on Hidden Creek Blvd. is full of weeds. There is no definitive edge, and many ornamental grasses are dead and should be removed.



10. Shoulder area along Hidden Creek Blvd., just North of Daisy Meadow Loop, is continuing to degrade due to cars parking on the turf at the bus stop. I recommend adding 'No Parking' signs to prevent having to make repairs to this area.(pic.10>>)

11. Palms near mailbox area on Daisy Meadow Loop have not been trimmed either.(pic.11)



12. Application placards that have been present for over a week should be removed during detail events. Placards only need to remain for 48 hrs..

13. Has there been a proposal to replace this area of turf on Daisy Meadow Loop in the spring?(pic.13>)

14. Grass beds near the retention pond in this same area need to be weeded.(pic.14>)



15. Area behind the same bed should be line trimmed during mow events.(pic.15>)

17. All tree rings in CDD maintained areas **HAVE** to be properly maintained. This includes maintaining a defined edge and keeping weeds and grasses out of the rings themselves. The rings are not only aesthetic, but functional. They prevent mechanical damage from mowers and line trimmers from injuring the tree. Every tree ring I observed had either weeds or now definitive edge. This needs to be corrected.(pic.16a,16b,16c>))

17. All bed spaces along Eiland Blvd are in a state of neglect. There is no defined edges around any of the beds near retention ponds or along fence lines. Weeds have over taken beds and plant material is missing, weak, or dead. Is the irrigation working in these areas?(pic.17a>,17b>,17c>>,17d>>,17e>>)

18. Has proposal been made to remove dead Sabal Palms along Eiland Blvd.?
(pic.18a,18b)



19. Weeds and tall grass around utility pole need to be line trimmed during mow events.(pic.19>>)

20. On the North side of retention pond Tract 'B-3', adjacent to the sports field privacy fence, one of the ornamental beds has been mowed through to cut a path. This is a bed that is so overgrown the mow crew decided to cut a trail through it. This needs to be repair and bed space redefined.(pic.20>>)

21. In this same area, on the North side of Tract 'B-3', there is a major erosion event taking place that is moving closer to the fence line adjacent to the baseball field. This issue needs to be investigated to determine what is causing the erosion and a plan set to correct the issue before it causes more damage.(pic.21a>,21b>)

22. Along the East bank of the same retention pond, adjacent to the back of the residences, there are areas of erosion occurring. This is not as bad as item #21, however, I recommend looking at these areas at the same time to come up with a solution.(pic.22a>,22b>>)

23. All irrigation and utility boxes in CDD maintained areas should be hard edged to ensure ease of locating these areas when needed.(pic.23a,23b)

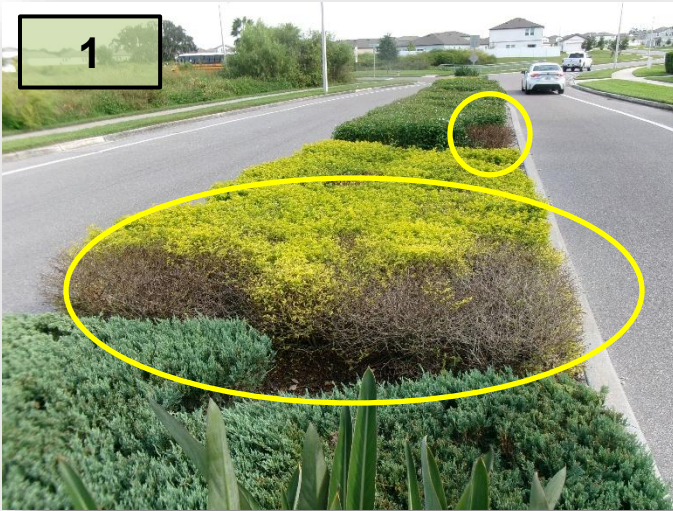


24. Border bed in between the back of the residences on Daisy Meadow Loop and the ball field have lost all bed definition. Plant material is weak and unmaintained.(pic.24)



Proposals

1. Juniper – Please provide a proposal to replace the dead Duranta Gold Mound and Jasmine shrubs in the front bed along Hidden Creek on the east side, with one full 3-gallon and to top off the area with pine bark mulch. Item #5. (Pic 1)



2. Following up on the proposal with Juniper, please provide a proposal to reshape the turf edge in this dead area into clean, straight lines, allowing for the installation of new Bahia turf squares at grade. The new turf should be installed flush with the concrete for a seamless appearance. Item #13. (Pic 2)



3. Removal of dead Sabal Palms along Eiland. Item #18.(pic.3a,3b)



4. Installation of 'No Parking' signs along Hidden Creek Blvd, just North of Daisy Meadow Loop to prevent cars from damaging turf. Item #10. (pic.4>>)
5. Inspection of erosion areas around Tract 'B-3' to find solution for washout areas and erosion along bank. Item #'s21 & 22.(pic.5a>>,5b>>,5c>>>,5d>>>)

Compliance Audit Overview

The Community Website Compliance Audit (CWCA) consists of a thorough assessment of Florida Community Development District (CDD) websites to assure that specified district information is available and fully accessible. Florida Statute Chapter 189.069 states that effective October, 2015, every CDD in the state is required to maintain a fully compliant website for reporting certain information and documents for public access.

The CWCA is a reporting system comprised of quarterly audits and an annual summary audit to meet full disclosure as required by Florida law. These audits are designed to assure that CDDs satisfy all compliance requirements stipulated in Chapter 189.069.

Compliance Criteria

The CWCA focuses on the two primary areas – website accessibility as defined by U.S. federal laws, and the 16-point criteria enumerated in [Florida Statute Chapter 189.069](#).



ADA Website Accessibility

Several federal statutes (American Disabilities Act, Sec. 504 and 508 of the Rehabilitation Act of 1973) require public institutions to ensure they are not discriminating against individuals on the basis of a person's disability. Community websites are required to conform to web content accessibility guidelines – [WCAG 2.1](#), which is the international standard established to keep websites barrier-free and the recognized standard for ADA-compliance.



Florida Statute Compliance

Pursuant to F.S. [189.069](#), every CDD is required to maintain a dedicated website to serve as an official reporting mechanism covering, at minimum, 16 criteria. The information required to report and have fully accessible spans: establishment charter or ordinance, fiscal year audit, budget, meeting agendas and minutes and more. For a complete list of statute requirements, see page 3.

Audit Process

The Community Website Compliance Audit covers all CDD web pages and linked PDFs.* Following the [WCAG 2.1](#) levels A, AA, and AAA for web content accessibility, a comprehensive scan encompassing 312 tests is conducted for every page. In addition, a human inspection is conducted to assure factors such as navigation and color contrasts meet web accessibility standards. See page 4 for complete accessibility grading criteria.

In addition to full ADA-compliance, the audit includes a 16-point checklist directly corresponding with the criteria set forth in Florida Statute Chapter 189.069. See page 5 for the complete compliance criteria checklist.

* **NOTE:** Because many CDD websites have links to PDFs that contain information required by law (meeting agendas, minutes, budgets, miscellaneous and ad hoc documents, etc.), audits include an examination of all associated PDFs. **PDF remediation** and ongoing auditing is critical to maintaining compliance.

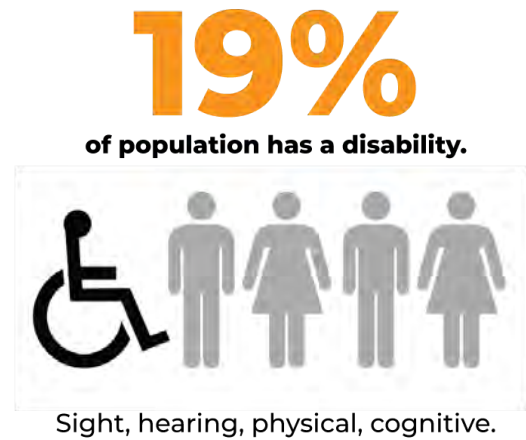

Accessibility overview

Everyone deserves equal access.

With nearly 1-in-5 Americans having some sort of disability – visual, hearing, motor, cognitive – there are literally millions of reasons why websites should be fully accessible and compliant with all state and federal laws. Web accessibility not only keeps board members on the right side of the law, but enables the entire community to access all your web content. The very principles that drive accessible website design are also good for those without disabilities.



The legal and right thing to do

Several federal statutes (American Disabilities Act, Sec. 504 and 508 of the Rehabilitation Act of 1973) require public institutions to ensure they are not discriminating against individuals on the basis of a person's disability. Community websites are required to conform to web content accessibility guidelines, WCAG 2.1, the international standard established to keep websites barrier-free. Plain and simple, any content on your website must be accessible to everyone.



ADA Compliance Categories

Most of the problems that occur on a website fall in one or several of the following categories.



Contrast and colors

Some people have vision disabilities that hinder picking up contrasts, and some are color blind, so there needs to be a distinguishable contrast between text and background colors. This goes for buttons, links, text on images – everything. Consideration to contrast and color choice is also important for extreme lighting conditions.

Using semantics to format your HTML pages

When web page codes are clearly described in easy-to-understand terms, it enables broader sharing across all browsers and apps. This ‘friendlier’ language not only helps all the users, but developers who are striving to make content more universal on more devices.



Text alternatives for non-text content

Written replacements for images, audio and video should provide all the same descriptors that the non-text content conveys. Besides helping with searching, clear, concise word choice can make vivid non-text content for the disabled.

Ability to navigate with the keyboard

Not everyone can use a mouse. Blind people with many with motor disabilities have to use a keyboard to make their way around a website. Users need to be able to interact fully with your website by navigating using the tab, arrows and return keys only. A “skip navigation” option is also required. Consider using [WAI-ARIA](#) for improved accessibility, and properly highlight the links as you use the tab key to make sections.

Easy to navigate and find information

Finding relevant content via search and easy navigation is a universal need. Alt text, heading structure, page titles, descriptive link text (no ‘click here’ please) are just some ways to help everyone find what they’re searching for. You must also provide multiple ways to navigate such as a search and a site map.

Properly formatting tables

Tables are hard for screen readers to decipher. Users need to be able to navigate through a table one cell at a time. In addition to the table itself needing a caption, row and column headers need to be labeled and data correctly associated with the right header.

PDF files must be tagged properly to be accessible, and unfortunately many are not. Images and other non-text elements within that PDF also need to be ADA-compliant. Creating anew is one thing; converting old PDFs – called PDF remediation – takes time.

Making videos accessible

Simply adding a transcript isn't enough. Videos require closed captioning and detailed descriptions (e.g., who's on-screen, where they are, what they're doing, even facial expressions) to be fully accessible and ADA compliant.

Forms are common tools for gathering info and interacting. From logging in to registration, they can be challenging if not designed to be web-accessible. How it's laid out, use of labels, size of clickable areas and other aspects need to be considered.

Alternate versions

Attempts to be fully accessible sometimes fall short, and in those cases, alternate versions of key pages must be created. That is, it is sometimes not feasible (legally, technically) to modify some content. These are the 'exceptions', but still must be accommodated.



Feedback for users

To be fully interactive, your site needs to be able to provide an easy way for users to submit feedback on any website issues. Clarity is key for both any confirmation or error feedback that occurs while engaging the page.



Other related requirements

No flashing

Blinking and flashing are not only bothersome, but can be disorienting and even dangerous for many users. Seizures can even be triggered by flashing, so avoid using any flashing or flickering content.

Timers

Timed connections can create difficulties for the disabled. They may not even know a timer is in effect, it may create stress. In some cases (e.g., purchasing items), a timer is required, but for most school content, avoid using them.

Fly-out menus

Menus that fly out or down when an item is clicked are helpful to dig deeper into the site's content, but they need to be available via keyboard navigation, and not immediately snap back when those using a mouse move from the clickable area.

No pop-ups

Pop-up windows present a range of obstacles for many disabled users, so it's best to avoid using them altogether. If you must, be sure to alert the user that a pop-up is about to be launched.

RESOLUTION 2026- 01

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE HIDDEN CREEK NORTH COMMUNITY DEVELOPMENT DISTRICT IMPLEMENTING SECTION 190.006(3), *FLORIDA STATUTES*, AND REQUESTING THAT THE PASCO COUNTY SUPERVISOR OF ELECTIONS CONDUCT THE DISTRICT'S GENERAL ELECTIONS; PROVIDING FOR COMPENSATION; SETTING FORTH THE TERMS OF OFFICE; AUTHORIZING NOTICE OF THE QUALIFYING PERIOD; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Hidden Creek North Community Development District ("**District**") is a local unit of special-purpose government created and existing pursuant to Chapter 190, *Florida Statutes*, being situated entirely within unincorporated Pasco County, Florida; and

WHEREAS, the Board of Supervisors of the District ("**Board**") seeks to implement Section 190.006(3), *Florida Statutes*, and to instruct the Pasco County Supervisor of Elections ("**Supervisor**") to conduct the District's elections by the qualified electors of the District at the general election ("**General Election**").

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE HIDDEN CREEK NORTH COMMUNITY DEVELOPMENT DISTRICT:

1. **GENERAL ELECTION SEATS.** Seat 4 currently held by Edward Schill and Seat 5 currently held by Michael J. Hunt are scheduled for the General Election in November 2026. The District Manager is hereby authorized to notify the Supervisor of Elections as to what seats are subject to General Election for the current election year, and for each subsequent election year.

2. **QUALIFICATION PROCESS.** For each General Election, all candidates shall qualify for individual seats in accordance with Section 99.061, *Florida Statutes*, and must also be a qualified elector of the District. A qualified elector is any person at least 18 years of age who is a citizen of the United States, a legal resident of the State of Florida and of the District, and who is registered to vote with the Pasco County Supervisor of Elections. Campaigns shall be conducted in accordance with Chapter 106, *Florida Statutes*.

3. **COMPENSATION.** Members of the Board receive \$200 per meeting for their attendance and no Board member shall receive more than \$4,800 per year.

4. **TERM OF OFFICE.** The term of office for the individuals to be elected to the Board in the General Election is four years. The newly elected Board members shall assume office on the second Tuesday following the election.

5. **REQUEST TO SUPERVISOR OF ELECTIONS.** The District hereby requests the Supervisor to conduct the District's General Election in November 2026, and for each subsequent General Election unless otherwise directed by the District's Manager. The District understands that it will be responsible to pay for its proportionate share of the General Election cost and agrees to pay same within a reasonable time after receipt of an invoice from the Supervisor.

6. **PUBLICATION.** The District Manager is directed to publish a notice of the qualifying period for each General Election, in a form substantially similar to **Exhibit A** attached hereto.

7. **SEVERABILITY.** The invalidity or unenforceability of any one or more provisions of this Resolution shall not affect the validity or enforceability of the remaining portions of this Resolution, or any part thereof.

8. **EFFECTIVE DATE.** This Resolution shall become effective upon its passage.
