Lake Saxon: Frank George Park

- 1. There is a slab and picnic table already there. It just needs a cabana.
- 2. Hydrilla is bad around dock area. Needs treating.
- 3. Paint Playground equipment

Park is very clean and looks good. Dock looks good.

#### Laird Park:

- 1. Bushes near palm trees could be trimmed down about a foot.
- 2. Concrete block has been thrown in boat ramp and needs to be removed.
- 3. Brazilian Pepper trees near dumpster should be trimmed. They are on the Sable Ridge land and are leaning over fence.
- 4. Paint playground equipment
- 5. Dead Palm tree- this is one of 6 on the list to be removed as too tall to manage any more.
- 6. Landscape timbers around flower beds are crumbling as well as in parking area.

At one point in time all cabanas there had electricity and fans. FYI Dock looks good.

A lot of eel grass is washing up on shorelines.

Wondering if swim area can be moved over more. It was put where it is due to contamination of water. The swell that was installed should be cleaning up the water quality and the buoys might be able to be move at the discretion of Steve, Tony an health dept.

#### Little East Lake:

- 1. Someone pried off top of fish feeder.
- 2. Sail shade has a hole in one of the sails.

There is a slab with a picnic table there already. It just needs a cabana. A third cabana would be nice nearer the play area.

Park looks good.

Dock looks good.

#### Stables:

- 1. Meeting room roof needs Silver Dollar Paint put on it per Steve.
- 2. Interior Fence has a few missing caps and one board with a crack.
- 3. Still need some wood boards and black paint in some areas.
- 4. Barns are still very clean.
- 5. Concrete barn needs weed whacking.

### Lake Padgett:

- 1. Replace bad boards on dock- only 2 or 3
- 2. Paint playground equipment
- 3. Volleyball area needs more sand- white sand not beach sand- There is a need for a lot of sand.
- 4. Landscape timbers need to be looked at due to rotting.
- 5. Sign at boat ramp about not power loading needs repair or replacing- very worn looking.

Overall look of park is good.

### Lake Joyce:

FYI: There is a slab and picnic table there. It only needs a cabana.

Park looked good- Area where trees were removed look good as do the trees that were trimmed.

This park looks good.

Dock looks good, but will need cleaning as some new type of water bird/duck is roosting there.

There are about 40 of them. I think they might be migrating.
