THIRD ORDER OF BUSINESS

Audience Comments

Ms. Castoria clarified that audience comments are to be made at designated times with a three-minute limit, on agenda items only, per Board policy to maintain meeting order and efficiency.

There was a brief discussion regarding the dock expansion at 3539 Lake Padgett Drive. It was noted by the resident that Pasco County directed them to seek a letter from the Board. District Counsel clarified that the lake bottom is owned by a private individual and not the District (ISD). District Counsel emphasized that the District (ISD) has no jurisdiction and therefore cannot provide approval nor assume liability. It was agreed after discussion and a motion that District Counsel would issue a letter for the resident indicating that the District (ISD) has no jurisdiction over the property in question.

On a Motion by Mr. Wells and seconded by Ms. Wakefield, with all in favor, the Board of Supervisors approved District Counsel to issue a letter for the resident indicating that the District (ISD) has no jurisdiction over the property in question for the Lake Padgett Estates Independent Special District.

There was a lengthy discussion regarding Ordinance, District, and Road Ownership Clarifications.

Clarification was provided about a 2019 ordinance and prior changes from 2000 related to ISD (Independent Special District) and County oversight.

The ordinance affects the application of revenues and jurisdictional issues for South Pasco County, as described on the district's website.

The board and audience discussed confusion around which entity owns or is responsible for roads and drainage in the district.

It was clarified that existing public rights of way (roads) were excepted from county-to-ISD deed transfers, and the county retains road ownership, not the ISD.

Ongoing issues with road maintenance, drainage, and required easements were mentioned, with some concern about the scope of county and ISD authority.

Residents described problems with aging drainage systems, collapsing pipes, and unclear responsibility for maintenance.

Concerns were raised about potential condemnation of homes for retention pond space if drainage issues are not resolved.

Discussion included the county's interest in establishing a municipal services taxing district to address infrastructure and sewer connectivity.

Worries about opening a larger set of problems if the county undertakes major drainage or road repairs due to historical design flaws.

A resident requested working financial documents of the ISD.

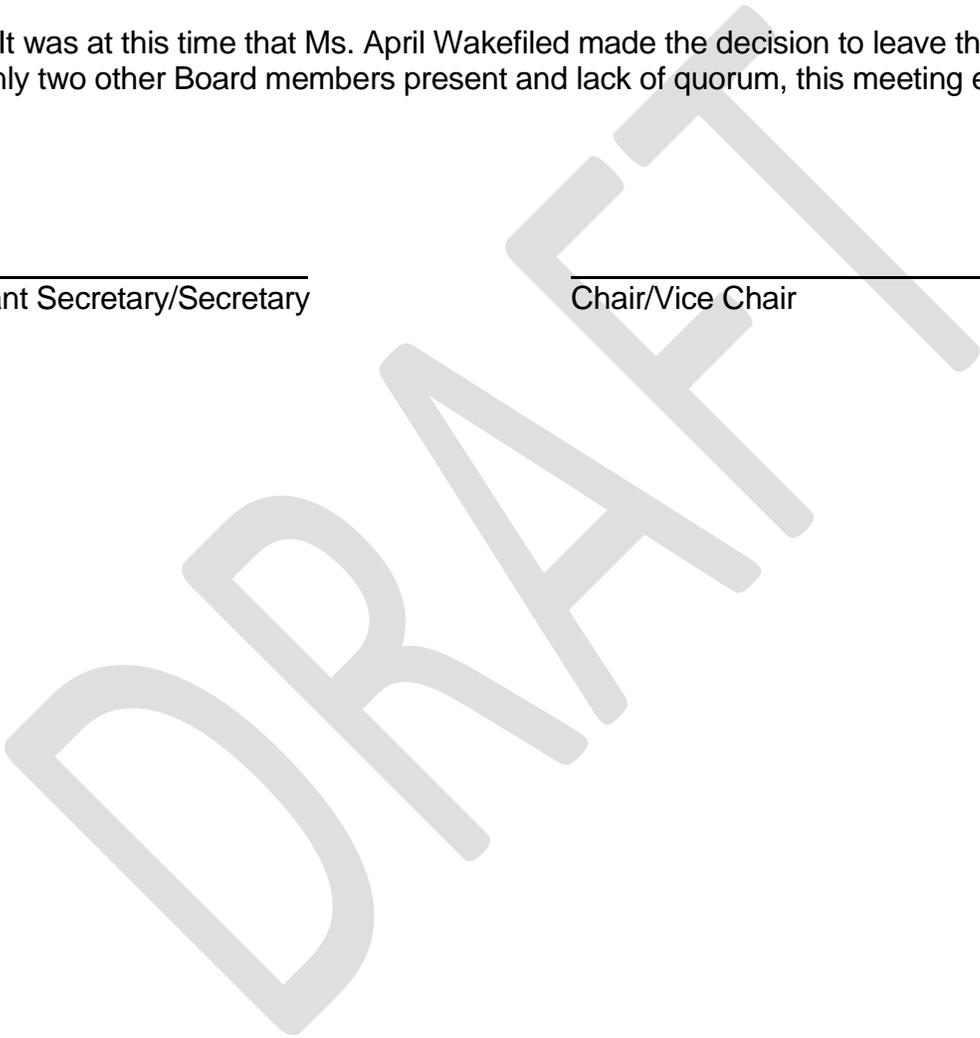
Mr. David Muller expressed his concern regarding Board financial decisions. There was a brief discussion about budget transparency and District policy to only share finalized Board approved documents to residents.

Part 1 – Canal Accessibility

Over the past two months, Mark and I have been able to service the canals more effectively due to higher water levels allowing full access.

Part 2 – Treatment Efficiency

With boat access, our treatments were applied more thoroughly, resulting in significantly improved coverage and overall canal condition.

Part 3 – Vegetation Results

Alligator weed: Fully controlled; plants are dead or actively dying off.

Duckweed: Substantially reduced and now confined to a single corner of the canal.

Part 4 – Overall Assessment

The canal system shows clear improvement following consistent boat-based treatments, with noticeable reductions in invasive vegetation and overall healthier water conditions.

Eelgrass coverage has noticeably reduced across all three water bodies and is now concentrated closer to the shoreline areas. Current treatment efforts remain focused in the central sections to avoid over-removal near the shore, as maintaining adequate eelgrass is important for preventing opportunistic species such as hydrilla from establishing.

Algae presence is minimal overall. The only active algae activity is located in the center portion of Lake Pageant. This is a significant improvement compared to previous months, where algae was observed across all three lakes and the pond.

Overall, conditions remain stable, and treatments are being applied strategically to preserve beneficial vegetation while mitigating potential invasive growth.

Eelgrass (Vallisneria) – Factual Benefits

Eelgrass is a highly beneficial native plant that helps maintain a healthy lake and pond system.

It absorbs excess nutrients such as nitrogen and phosphorus, improving water clarity and limiting algae growth.

The plant stabilizes sediments, reducing shoreline erosion and preventing mud and debris from being stirred into the water column.

Eelgrass produces oxygen through photosynthesis, improving overall water quality and supporting fish and aquatic life.

Dense eelgrass beds serve as critical habitat, increasing fish abundance, protecting juvenile species, and improving biodiversity.

It also contributes to carbon storage, helping maintain long-term ecological stability.

Hydrilla – Factual Problems & Rapid Growth

Hydrilla is a harmful invasive species that quickly overtakes lakes and ponds.

It has extremely fast growth rates—capable of growing several inches per day and doubling its biomass in two weeks during peak season.

Hydrilla spreads aggressively through fragments, tubers, and buds, making it very difficult to eradicate.

It forms thick surface mats that block sunlight, kill native vegetation, and drastically reduce biodiversity.
 Dense hydrilla beds interfere with water flow, oxygen levels, and pH, which can stress or kill fish.
 Heavy infestations obstruct boating, fishing, and water circulation, often leading to higher management and treatment costs.
 Tubers remain viable in the soil for years, causing reinfestation even after treatments.
 I highly recommend that both canals on Lake Padgett receive a dredging quote. The current depth is limiting access, and dredging would significantly deepen the channels, improve water flow, and allow boats to navigate through much more efficiently. This would provide long-term benefits for both water quality and property usability.

CUSTOMER understands that under agreement of this type, aquatic weeds can re-grow between treatments; therefore, no length of control is guaranteed.

- CUSTOMER understands that work under this Agreement is contingent upon review and approval by the EPC and FWC and that any supplemental conditions imposed by the EPC and FWC may not be included in the contents of this Agreement.
- CUSTOMER agrees to pay A & B AQUATICS monthly, its agents or assigns, the following amount for specified aquatic management services.

Contract - Aquatic Services Agreement

- Minimum of 12 inspections yearly with treatment as required.
- Licensed aquatic spray applicator to visit property twelve (12) times per year to remove any visible garbage.
- Specific Waterway Services:
 - Blue dye as needed
 - Control of all nuisance aquatic vegetation and algae (submersed, emersed & floating)
 - Control of shoreline grass
 - Usage of an Argo, (A neighborhood friendly amphibious vehicle that makes aquatic spraying ideal)
 - Note: Argos are quiet and can travel on land or water without causing any damage to the grass or shoreline.
 - Other equipment used: Airboat, four wheeler, side by side, jon-boat and backpack sprayers.

Total Cost of Services Provided (Monthly): \$ 1,875

The canal system shows clear improvement following consistent boat-based treatments, with noticeable reductions in invasive vegetation and overall healthier water conditions.

Eelgrass coverage has noticeably reduced across all three water bodies and is now concentrated closer to the shoreline areas. Current treatment efforts remain focused in the central sections to avoid over-removal near the shore, as maintaining adequate eelgrass is important for preventing opportunistic species such as hydrilla from establishing.

Algae presence is minimal overall. The only active algae activity is located in the center portion of Lake Pageant. This is a significant improvement compared to previous months, where algae was observed across all three lakes and the pond.

Overall, conditions remain stable, and treatments are being applied strategically to preserve beneficial vegetation while mitigating potential invasive growth.

Eelgrass (Vallisneria) – Factual Benefits

Eelgrass is a highly beneficial native plant that helps maintain a healthy lake and pond system.

Hydrilla spreads aggressively through fragments, tubers, and buds, making it very difficult to eradicate.

It forms thick surface mats that block sunlight, kill native vegetation, and drastically reduce biodiversity.

Dense hydrilla beds interfere with water flow, oxygen levels, and pH, which can stress or kill fish.

Heavy infestations obstruct boating, fishing, and water circulation, often leading to higher management and treatment costs.

Tubers remain viable in the soil for years, causing reinfestation even after

Please find the summary of current activities below:

1) Beach Testing

The January test results are attached. The water quality at both Lake Padgett and Laird Parks is good. February test results have not been received as of the date of this report.

2) Laird Swale and Beach Water Quality

I visited the park on 2/8 and inspected the swale that conveys runoff from Parkway Boulevard to the lake. The displaced rip rap needs to be collected and moved back to the swale. A minor improvement for water quality that could be done would be to excavate the areas between the rip rap locations. This will provide some water quality improvement as it will trap some sediments and runoff to infiltrate into the ground. The improvement will be minor since the amount area available for storage is very small. Please refer to the attached photos.

I serve as the District Legal Counsel for the Lake Padgett Estates Independent Special District ("LPEISD"). LPEISD is a local unit of special-purpose government created and existing pursuant to Chapter 189, Florida Statutes, being situated entirely within Pasco County, Florida.

The subdivision, Lake Padgett Estates, predated mandatory HOAs and the imposition of CDD's. It consists of 1038 residential homes (over 1800 registered voters) and is one of the oldest residential subdivisions in Central Pasco County. Contained within Lake Padgett Estates are several large parks and recreational facilities that were conveyed by the developer to the Lake Padgett Municipal Service Unit, a governmental subdivision of Pasco County, Florida commencing in May of 1978 (OR 955, Pages 160-161, Public Records of Pasco County, Florida). Through this municipal services unit (MSU) Pasco County acquired control over these parks and recreational facilities and managed them for many years as an MSU on behalf of the residents of Lake Padgett Estates.

In 1990 Wayne and Violet Woodward, the previous owners of the property now referred to as "The Lakes of Camp David", brought a lawsuit against the Lake Padgett MSU over a dispute involving the property line between the two properties. (See Woodward vs Lake Padgett Municipal Service Unit, et. al., Case No. 90-2782-CA, Div. B). The parties reached a settlement

in June of 1993 which resulted in "Boundary Agreement" between the parties (O.R. 3162, PGS 1550-1561, Public Records of Pasco County, Florida). As per the terms of this agreement the MSU agreed to "install a fence along the southern boundary line of their now agree upon boundary". The purpose of the fence was "to separate the Woodward tracts and Lake Padgett tracks under this agreement". This fence was constructed and remains today as the agreed upon boundary between these two tracts of land.

In 2006 the MSU was converted to LPEISD, an independent special district established by the Florida Legislature for the primary benefit of Lake Padgett Estate residents (Special Act 2006-317, Laws of Florida). Section 3 of this enacting legislation provided the legal description of the boundaries of the LPEISD which encompasses the entire residential subdivision commonly referred to as "Lake Padgett Estates". In furtherance of this enacting legislation on May 31, 2007, Pasco County via a deed of conveyance transferred ownership from Pasco County to LPEISD of all properties within LPEISD designated "for recreational purposes ... as described more fully in Special Act 2006-317, Laws of Florida". This conveyance did not "include roads, drainage and any interest in said properties of a non-recreational nature." (See OR 7517, PGS 589-613, Public Records of Pasco County, Florida)

LPEISD is governed by a Board of Supervisor who serve four-year terms as elected by the residents of Lake Padgett Estates. The Board of Supervisors have very limited authority and can only operate, maintain and preserve the recreational facilities within the District. They DO NOT have any legal authority to convey any legal interest in District property.

In 2023 LPEISD was approached by the Woodward family who at that time owned a large tract of land adjacent to the Southern boundary of LPEISD's park on Lake Padgett. This property is now owned by David Mitchell and is the proposed as the "The Lakes at Camp David". Woodward provided LPEISD with a boundary survey performed in 2022 by Eddie Jenkins Surveying. This boundary survey accurately depicted the boundaries between the two properties as per a "Boundary Agreement" between the MSU and Woodward, and subject to a Corrective Easement for Ingress/Egress between Pasco County and Elizabeth Delaney dated May 18, 1987 (O.R. 1608, Page 1491 of the Public Records of Pasco County. **This 2022 survey showed that Woodward accessed their property via an ingress/egress extending from Wilsky Road.**

In early 2025 LPEISD was contacted by Mr. David Mitchell who presented the District with a survey he had done by Johnson and Associates in 2024. Mr. Mitchell attempted to claim legal access to Rain Forest Place. However, Mr. Mitchell's survey failed to note the previous 1992 "Boundary Agreement" between Pasco County and Woodward, despite the fact this agreement was of public record and the boundary line was further memorialized by an existing fence clearly depicted on his 2024 survey. **This 2024 survey, just as the Woodward's 2022 survey had documented, showed that Mr. Mitchell has an ingress/egress easement extending from Wilsky Road (see attached Exhibit "A").**

Twice LPEISD has invited Mr. Mitchell to attend their monthly meetings to discuss his proposed development and twice, at the last minute, Mr. Mitchell canceled. The public forums were nonetheless held and the Board of Supervisors of LPEISD heard from Lake Padgett residents who unanimously expressed their opposition to Mr. Mitchell's intention to access his proposed

development through Lake Padgett Estates. There were numerous reasons given for their opposition; some of these concerns are listed as follows:

- 1.) Increased traffic along Lake Padgett Drive and Rain Forrest Place within Lake Padgett Estates both of which had originally been designed, approved and constructed as dead ends;
- 2.) Damage to roadways and bridges within Lake Padgett Estates caused by heavy construction equipment and increased traffic, specifically the bridge across the Lake Padgett and Lake Saxon canal which serves as the only access point for the 25 Lake Padgett Estate homes and large LPEISD park that are located in this area;
- 3.) Disruption of the park activities via an additional access roadway. The roadways within Lake Padgett Estates do not include any sidewalks; residents walking, biking or golf carting to this park must utilize the narrow roadways (Lake Padgett Estates is a designated golf cart community);
- 4.) Access to the gated park by non-residents.
- 5.) Residents also noted that Mr. Mitchell's property had a pre-existing ingress/egress easement via Carson Drive and Wilsky Road, two county-maintained roadways on its Southern boundary.

The 25 residents that live along the ends of Forest Place and Lake Padgett Drive were most vocal in their opposition to access through Lake Padgett Estates. Many voiced that they had lived in their homes for many years and had chosen their homes because these roadways were "quiet dead-end roadways" with "very limited traffic". Some residents pointed out that they had paid premium prices because their homes were located on a cul-de-sac with limited traffic. This section of Lake Padgett Estates has one access point across a narrow bridge that spans the canal between Lake Padgett and Lake Saxon.

In reviewing correspondence from the Pasco County regarding this matter it is my understanding that it is the County's position that because the Pasco County Land Development Code does not prohibit the conversion of a cul-de-sac in one subdivision to an access point for another subdivision, such must be approved. I find this logic verging on the outright absurd!

I have been a real estate attorney for over 43 years and have represented numerous residential and commercial developers during that time. If the intention is to establish a future thoroughfare between developments the road is either stubbed out with a breakaway barrier or a simple "T". In some cases I have even seen where the cul-de-sac actually borders the adjoining property. This puts everyone on clear notice that the roadway will eventually connect to the adjoining parcel. However, when the cul-de-sac is solely within one subdivision and its entire boundary encompasses residential homes within the original subdivision, clearly the intention was that the roadway never was intended as a thoroughfare. People buying homes in the original subdivision have every reason to rely on this and developers and builders often sell these homes at premium prices because of this.

When I bought my first house in 1982 in Pasco County my wife and I sought out a homesite located on a cul-de-sac because we wanted limited traffic and a place where our future children could feel safe playing. We paid a premium of \$2,500.00 to purchase a lot on a cul-de-sac.

I shudder to think of the legal precedent this sets throughout Pasco County that any cul-de-sac can now be converted by a developer merely by buying a home at the end of the cul-de-sac and then demanding that the County designate it a thorough-fare to the adjoining property which they intend to develop. This certainly destroys the whole concept of MPUD's and PUD's as well as the character and sanctity of older established residential communities.

Certainly Mr. Mitchell has every right to develop his property in conformity with zoning, land use and applicable land development codes; but he does not have a right to do it at the expense of an existing established residential community and the residents that live within it. The intent behind zoning, land use designations and land development codes has always been the health, safety and welfare of the residents of Pasco County.

Both the survey provided to LPEISD by the previous landowner (Woodward) in 2023 and the survey provided to LPEISD by the current landowner documents an existing ingress/egress easement off Wilsky Road which negates the need for an access point through Lake Padgett Estates. And as clearly depicted on the Pasco County Property Appraiser's aerial photo maps this same ingress/egress provides access to the homes located on the seven lots on Lake Saxon that adjoin the applicant's northern boundary.

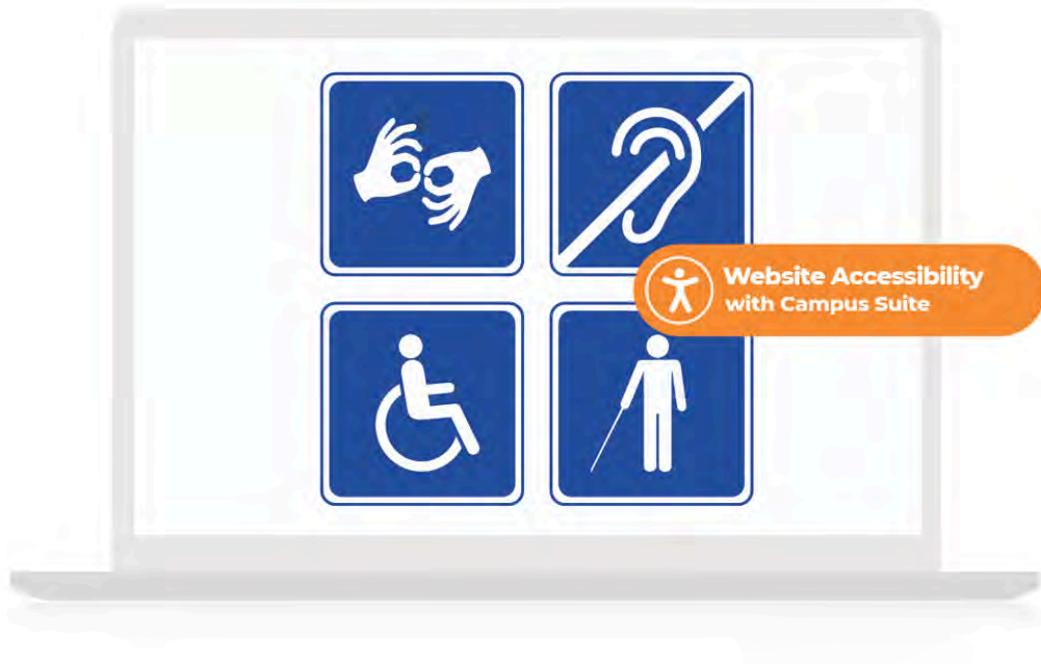

Compliance Audit Overview

The Community Website Compliance Audit (CWCA) consists of a thorough assessment of Florida Community Development District (CDD) websites to assure that specified district information is available and fully accessible. Florida Statute Chapter 189.069 states that effective October, 2015, every CDD in the state is required to maintain a fully compliant website for reporting certain information and documents for public access.

The CWCA is a reporting system comprised of quarterly audits and an annual summary audit to meet full disclosure as required by Florida law. These audits are designed to assure that CDDs satisfy all compliance requirements stipulated in Chapter 189.069.

Compliance Criteria

The CWCA focuses on the two primary areas – website accessibility as defined by U.S. federal laws, and the 16-point criteria enumerated in [Florida Statute Chapter 189.069](#).



ADA Website Accessibility

Several federal statutes (American Disabilities Act, Sec. 504 and 508 of the Rehabilitation Act of 1973) require public institutions to ensure they are not discriminating against individuals on the basis of a person's disability. Community websites are required to conform to web content accessibility guidelines – [WCAG 2.1](#), which is the international standard established to keep websites barrier-free and the recognized standard for ADA-compliance.



Florida Statute Compliance

Pursuant to F.S. [189.069](#), every CDD is required to maintain a dedicated website to serve as an official reporting mechanism covering, at minimum, 16 criteria. The information required to report and have fully accessible spans: establishment charter or ordinance, fiscal year audit, budget, meeting agendas and minutes and more. For a complete list of statute requirements, see page 3.

Audit Process

The Community Website Compliance Audit covers all CDD web pages and linked PDFs.* Following the [WCAG 2.1](#) levels A, AA, and AAA for web content accessibility, a comprehensive scan encompassing 312 tests is conducted for every page. In addition, a human inspection is conducted to assure factors such as navigation and color contrasts meet web accessibility standards. See page 4 for complete accessibility grading criteria.

In addition to full ADA-compliance, the audit includes a 16-point checklist directly corresponding with the criteria set forth in Florida Statute Chapter 189.069. See page 5 for the complete compliance criteria checklist.

* **NOTE:** Because many CDD websites have links to PDFs that contain information required by law (meeting agendas, minutes, budgets, miscellaneous and ad hoc documents, etc.), audits include an examination of all associated PDFs. **PDF remediation** and ongoing auditing is critical to maintaining compliance.

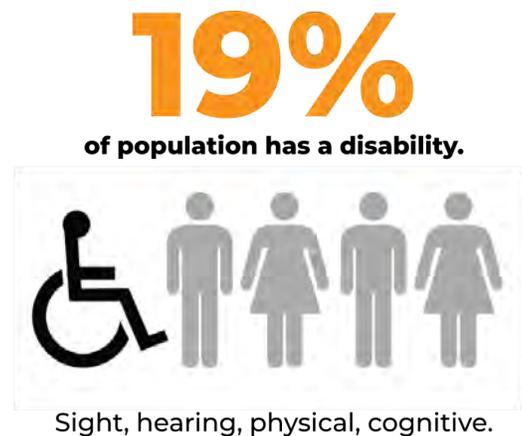

Accessibility overview

Everyone deserves equal access.

With nearly 1-in-5 Americans having some sort of disability – visual, hearing, motor, cognitive – there are literally millions of reasons why websites should be fully accessible and compliant with all state and federal laws. Web accessibility not only keeps board members on the right side of the law, but enables the entire community to access all your web content. The very principles that drive accessible website design are also good for those without disabilities.



The legal and right thing to do

Several federal statutes (American Disabilities Act, Sec. 504 and 508 of the Rehabilitation Act of 1973) require public institutions to ensure they are not discriminating against individuals on the basis of a person's disability. Community websites are required to conform to web content accessibility guidelines, WCAG 2.1, the international standard established to keep websites barrier-free. Plain and simple, any content on your website must be accessible to everyone.



ADA Compliance Categories

Most of the problems that occur on a website fall in one or several of the following categories.



Contrast and colors

Some people have vision disabilities that hinder picking up contrasts, and some are color blind, so there needs to be a distinguishable contrast between text and background colors. This goes for buttons, links, text on images – everything. Consideration to contrast and color choice is also important for extreme lighting conditions.

Using semantics to format your HTML pages

When web page codes are clearly described in easy-to-understand terms, it enables broader sharing across all browsers and apps. This ‘friendlier’ language not only helps all the users, but developers who are striving to make content more universal on more devices.



Text alternatives for non-text content

Written replacements for images, audio and video should provide all the same descriptors that the non-text content conveys. Besides helping with searching, clear, concise word choice can make vivid non-text content for the disabled.

Ability to navigate with the keyboard

Not everyone can use a mouse. Blind people with many with motor disabilities have to use a keyboard to make their way around a website. Users need to be able to interact fully with your website by navigating using the tab, arrows and return keys only. A “skip navigation” option is also required. Consider using [WAI-ARIA](#) for improved accessibility, and properly highlight the links as you use the tab key to make sections.

Easy to navigate and find information

Finding relevant content via search and easy navigation is a universal need. Alt text, heading structure, page titles, descriptive link text (no ‘click here’ please) are just some ways to help everyone find what they’re searching for. You must also provide multiple ways to navigate such as a search and a site map.

Properly formatting tables

Tables are hard for screen readers to decipher. Users need to be able to navigate through a table one cell at a time. In addition to the table itself needing a caption, row and column headers need to be labeled and data correctly associated with the right header.

PDF files must be tagged properly to be accessible, and unfortunately many are not. Images and other non-text elements within that PDF also need to be ADA-compliant. Creating anew is one thing; converting old PDFs – called PDF remediation – takes time.

Making videos accessible

Simply adding a transcript isn't enough. Videos require closed captioning and detailed descriptions (e.g., who's on-screen, where they are, what they're doing, even facial expressions) to be fully accessible and ADA compliant.

Making forms accessible

Forms are common tools for gathering info and interacting. From logging in to registration, they can be challenging if not designed to be web-accessible. How it's laid out, use of labels, size of clickable areas and other aspects need to be considered.

Alternate versions

Attempts to be fully accessible sometimes fall short, and in those cases, alternate versions of key pages must be created. That is, it is sometimes not feasible (legally, technically) to modify some content. These are the 'exceptions', but still must be accommodated.



Feedback for users

To be fully interactive, your site needs to be able to provide an easy way for users to submit feedback on any website issues. Clarity is key for both any confirmation or error feedback that occurs while engaging the page.



Other related requirements

No flashing

Blinking and flashing are not only bothersome, but can be disorienting and even dangerous for many users. Seizures can even be triggered by flashing, so avoid using any flashing or flickering content.

Timers

Timed connections can create difficulties for the disabled. They may not even know a timer is in effect, it may create stress. In some cases (e.g., purchasing items), a timer is required, but for most school content, avoid using them.

Fly-out menus

Menus that fly out or down when an item is clicked are helpful to dig deeper into the site's content, but they need to be available via keyboard navigation, and not immediately snap back when those using a mouse move from the clickable area.

No pop-ups

Pop-up windows present a range of obstacles for many disabled users, so it's best to avoid using them altogether. If you must, be sure to alert the user that a pop-up is about to be launched.

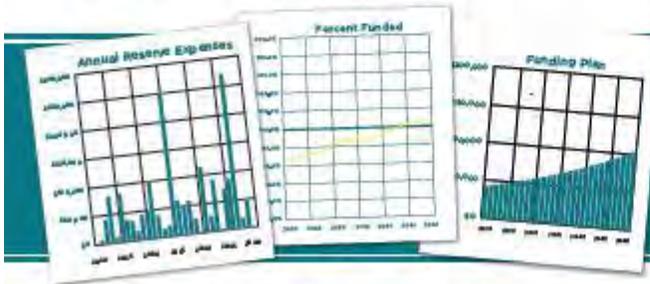

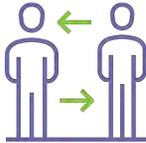

RA will include (and you hereby agree that RA may include) your name in our client lists.
