Re: New River Lakes Conservation Easement – FEE ADJUSTMENT

District Manager,

As per our agreement, we are to renegotiate our annual fee charged for easement monitoring and reporting as necessary to account for cost of living increases. This letter serves to advise you that there will be an increase in our Annual Inspection and Reporting Fee by approximately 5%. This increase is guided by the Consumer Price Index (CPI) Inflation Calculator (https://www.bls.gov/data/inflation_calculator.htm). We've attached an image of the adjustment calculation below, for your reference.

The increase equates to \$302.27, which brings the annual fee up from \$5,984.00 to \$6,286.27. If this recommended adjustment is acceptable, please sign this letter which will serve as an updated contractual agreement.

This fee increase will go into effect once the contract is signed (2025) and is scheduled to be renegotiated at the end of 2027.


