## **Select Amenities Scheduled To Reopen**

## Friday, May 15<sup>th</sup>

During the Monday, May 11<sup>th</sup> continuation meeting, the Board of Supervisors approved the following amenities to reopen on Friday, May 15<sup>th</sup>. The Phase I Reopening of the select amenities is in effect until further notice and in consideration of Governor DeSantis' executive Order 20-112 outlining the State of Florida's 3-Phase Plan for recovery. The CDD Board of Supervisors, Rizzetta & Company, Egis Insurance & Risk Advisors, and District Counsel will continue to closely monitor all communications from the Center of Disease Control and Prevention (CDC), the Florida Department of Health and the local, state, and federal authorities. Additional openings will be considered at a later date.

#### **Three Key Components to the Reopening:**

- Residents under the age of 17 must be accompanied by an adult.
- Use of amenities is for Residents Only. No Guests.
- Hours of Operation are limited to 9am 7pm for the open amenities.

### Amenities Scheduled to Reopen on Friday, May 15th.

- Jacuzzi Use at 40% capacity. (3 residents) Limited hours of operation. Reservation required.
- Lagoon Pool Use at 40% capacity. (19 residents) Limited hours of operation. Reservation required.
- Lap Pool Use at 40% capacity. (30 residents) Limited hours of operation. Reservation required.
- Tennis Courts Singles play only.
- Cormorant Cove Dock
- General Store
- Lodge Dock
- Lodge Fire Pit
- Lodge Outdoor Areas Excluding the Basketball Court and Lodge Playground.
- Lodge Lobby Excluding the Business Center and Coffee Station.
- Nail Salon

Please note the following temporary guidelines for the reopening of each amenity. \*Use of all amenities is subject to the Phase I Guidelines.

### **Phase I Guidelines**

- Use of amenities is reserved for Resident Use Only.
- Residents under the age of 17 must be accompanied by an adult.
- Use of amenities is at your own risk.
- Utilization of No Touch Thermal Thermometers to determine access to the Lodge amenities and Nail Salon is required. (Temperatures above 100.4 degrees will be denied access.)
- Abide by the CDC Social/Physical Distancing Guidelines Keep a distance of at least 6' between you and other people outside of your home.

- Limit gatherings to less than 10 people.
- Stay out of crowded areas and avoid mass gatherings.
- Nail Salon patrons to execute a Waiver of Liability before services are rendered.
- Nail Salon Technician to wear a mask during the services.
- Patrons are highly encouraged to wear a mask during the services.
- Failure to comply with the Phase I Guidelines may result in suspensions and/or trespassing.

# <u>Aquatics To Open - Jacuzzi, Lagoon Pool, and Lap Pool</u> (Splash Pad, Saunas, Grills, and Indoor Showers To Remain Closed)

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Use of the Aquatics is reserved for Resident Use Only.
- Residents under the age of 17 must be accompanied by an adult.
- Reservations for usage is via telephonic and/or email communications up to 24 hours in advance. 813-995-2437 or tdobson@wlplodge.com
- Usage of the Aquatics is set in sessions of 1 hour and 45 minutes.
- Cleaning of poolside furniture and Locker Room facilities between each session. (30-45 minutes, if necessary)
- Limit of 1 reservation per day, per person.
- Usage is limited to a capacity of 40% of the bathing load for each body of water. Total of 52 in combination per session.
  - Jacuzzi 3 residents
  - Lagoon Pool 19 residents
  - o Lap Pool 30 residents

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Singles play only.
- No lessons.
- Residents under the age of 17 must be accompanied by an adult.

## Cormorant Cove Dock & Lodge Dock

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Residents under the age of 17 must be accompanied by an adult.

## **General Store**

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Staff will handle and process each order to minimize contact of merchandise.
- Residents under the age of 17 must be accompanied by an adult.

#### Lodge Fire Pit

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Residents under the age of 17 must be accompanied by an adult.

### Lodge Outdoor Areas - Excluding the Basketball Court and Lodge Playground

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Outdoor games will be available for use. (Corn hole, Little Tot Golf, etc.)
- Residents under the age of 17 must be accompanied by an adult.

## **Lodge Lobby - Excluding the Business Center and Coffee Station**

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Faxing and Copier Services to be performed by Staff.
- Residents under the age of 17 must be accompanied by an adult.

#### **Nail Salon**

- Hours of Operation: 9am 7pm Sunday thru Saturday
- Services available to Residents Only.
- Nail Salon patrons to execute a Waiver of Liability before services are rendered.
- Nail Salon Technician will wear a mask during the services.
- Patrons highly encouraged to wear a mask during the services.
- Utilization of No Touch Thermal Thermometers to determine access to the Lodge amenities and Nail Salon is required. (Temperatures above 100.4 degrees will be denied access.)
- Cleaning and sanitation period of no less than 15 minutes between each appointment.
- Residents under the age of 17 must be accompanied by an adult.

While the Phase I Reopening plan may not be ideal, it is necessary to maintain the quality of health, safety, and welfare of the residents and staff of the Preserve at Wilderness Lake. We thank you for your support and cooperation during all of the Reopening Phases.
