### 3 MOWING/EDGING/TRIMMING

The turf was mowed, edged, trimmed neatly and the hard surfaces were cleaned up in accordance with the specifications. The turf is now growing slowly and will be mowed every other week as per contract. Only mow turf that is actively growing. If turf does not need to be mowed, the labor resources for the mowing operation must be used for other contractual obligations, such as woodline cutbacks.

Boulevard from Lodge to main entry- turf color was a lightly mottled medium green.

Citrus Blossom park common area- turf color was a lightly mottled medium green.

Stoneleigh park- turf color of the common Bermudagrass turf color was a mottled medium green, as it goes into its dormant period.

Lodge- turf color of the main lawn remained a consistent medium to a consistent dark green.

Oakhurst park- turf color of the common Bermudagrass turf color was a mottled medium green, as it goes into its dormant period.

Kendall Heath/Waverly Shores- turf color of the common Bermudagrass was a mottled medium green color. The St. Augustine turf color was also a mottled medium green.

Night Heron/Caliente intersection- turf color was a lightly mottled medium green.

Roundabout- turf color remained a consistent medium to a consistent dark green.

# **3 TURF DENSITY**

Kendall Heath/Waverly Shores- the density of the common Bermudagrass remained fair as it goes into its dormant period. The density of the St. Augustine was good along the parkway.

Boulevard from Lodge to main entry- the density was good

Citrus Blossom park- the density was good.

Citrus Blossom common area- the density was good.

Stoneleigh park- the common Bermudagrass density was good, as it goes into its dormant period.

Oakhurst park- the common Bermudagrass density was good, as it goes into its dormant period.

Night Heron/Caliente intersection- the density was good.

Lodge- the density of the main entry lawn, front lawn, nature center lawn and rear lawn was good.

Tennis court- the density around the tennis court was good along the backside of the court and remained fair along the boulevard.

The Bahia turf density was good throughout the property, as it goes into its dormant period.

# 2 TURF WEED CONTROL

There was an increase in the volume of broadleaf weeds over the past month.

Oakhurst Park- treat broadleaf weeds by the pines.

Lodge playground- treat broadleaf weeds.

Caliente/Night Heron intersection- treat broadleaf weeds. *Photo below*.



Stoneleigh park- treat broadleaf weeds along sidewalks.

Main entry and exit parkway- treat broadleaf weeds.

Lodge playground- treat broadleaf weeds.

Americus- treat broadleaf weeds.

Waters Edge exit- treat broadleaf weeds.

Crabgrass has infested some of the high visibility turf areas throughout the community. It will die off when the cooler temperatures arrive. Pre-emergent herbicides must be applied at the appropriate time in order to suppress grassy weed growth.

# 3 TURF INSECT/DISEASE CONTROL/OVERALL HEALTH

The turf is being mowed and trimmed properly in accordance with the specification. Only mow turf that is actively growing. The color was generally a lightly mottled medium green throughout most of the community. The density remained strong, but the common Bermudagrass and Bahia will soon be in their dormant period. The volume of broadleaf weeds as well as the crabgrass growth increased over the past month. Broadleaf weeds need to be treated with herbicide. There were no indications of turf insect activity but patch disease was present in a few locations. The fall fertilization will help encourage root growth. Preemergent herbicide shall be applied when the soil temperature is appropriate in order to help suppress grassy weeds.

# 3 SHRUB-TREE INSECT/DISEASE CONTROL/OVERALL HEALTH

Deerfields berm- tape off area of newly installed viburnum so they don't get damaged.

Natures Ridge- remove all nandina. They are not growing or providing any landscape interest.

WLB median at Natures Ridge- replace missing and dead lorapetalum.

Eagle's Nest- ixora are chlorotic and need acidic fertilizer.

Pool deck entry gate- remove declining nettle plum by grill.

Lodge patio- Washingtonia palm in decline be. Photo below.



Wilderness Lake Boulevard median at roundabout- treat Fakahatchee grass for spider mites.

Deerfields entry gate- treat Fakahatchee grass for spider mites.

Butterfly garden- plants are healthy.

Stoneleigh common area- spray tree rings around maples. Bark is being damaged by mowers and line trimmers. *Photo below.* 



# 2 BED / CRACK WEED CONTROL

Wilderness Lake Boulevard at Pine Knot-remove vines from magnolia.

Tennis court fence perimeter- remove bed weeds.

Nature Center and amenity center- remove vines from the front of buildings.

Lodge patio- remove vines from schilling hollies and coontie palms.

Osprey Point monument- remove bed weeds.

Eagle's Grove monument- remove bed weeds.

Minnow Brook- treat crack weeds.

Sparrow wood monument- remove vines.

Cormorant Cove medians- remove bed weeds.

Roundabout- remove bed weeds and weed trees.

Oakhurst park- remove bed weeds from tree rings by playground.

Oakhurst lift station- remove bed weeds.

Roundabout- remove weed trees in center.

# **3 IRRIGATION MANAGEMENT**

The landscape appears to be receiving sufficient irrigation. There did not appear to be any significant leaks or breaks.

Lodge- check irrigation to window boxes. Make sure boxes properly drain.

General work order- monitor irrigation in areas prone to patch disease.

# **3 SHRUB PRUNING**

\*It should be noted that the shrubs, including but not limited to, the hawthorns and schilling hollies, should not be pruned too tightly. This means that too much vegetative growth is being removed, limiting the plants availability to make food for itself. In addition, the plant will look more attractive by not having "holes" in it, and allowing it to develop its more natural shape. (i.e. Indian Hawthorn has a natural mounded habit)

General work order- do not "flat top" hawthorns. Only stray shoots should be hand pruned in order to maintain their compact, mounded habit.

Pool filter- prune shrubs by chlorine container.

Lodge patio- prune Japanese blueberry away from light pole.

Waverly Shores/Kendall Heath- prune silverthorn.

Lodge side entrance-remove jasmine from shingles. Photo below.



Sparrow wood monument- prune juniper away from landscape lighting. MISSED FROM LAST MONTH. *Photo below*.



Butterfly garden- cut back sage and remove and replace milkweed. Photo below.

# **2 TREE PRUNING**

Citrus Blossom playground- prune oak away from shade structure.

Waters Edge entry pedestrian gate- prune tree off of roof and top of bottlebrush.

Exit drive from pediatric office- lift oak tree over sidewalk.

Tennis court side- remove broken queen palm fronds hanging over fence.

Heron's Wood monument- lift all oak trees.

Cardinal Wood- prune ligustrum.

Wilderness Lake Boulevard across from Lakewood Retreat- remove heavy moss accumulation from crape myrtles.

Wilderness Lake Boulevard across from Bircholm-remove heavy moss accumulation from crape myrtles.

Wilderness Lake Boulevard at Quail Trace- remove heavy moss accumulation from crape myrtles.

Caliente/Night Heron intersection- lift oak tree and remove moss from crape myrtles. Photo below.



Wilderness Lake Boulevard across from Bircholm- remove moss from crape myrtles.

Eagle's Crest monument- prune ligustrum trees.

Wilderness Lake Boulevard in front of lodge- remove moss from crape myrtles.

# 3 CLEANUP/RUBBISH REMOVAL

Stoneleigh park lift station- remove litter and vegetative debris.

There was not a significant amount of litter or vegetative debris that needed to be removed.

# **3 APPEARANCE OF SEASONAL COLOR**

Window boxes- new potting mix needs to be incorporated. Check boxes for proper drainage and irrigation as flowers have not had a strong display. *Photo below*.



Butterfly garden-remove some sage plants to increase the size of flower bed. Photo below.



The seasonal color display of marigolds and salvia was providing a strong curb appeal at all locations. The flowers will be changed out shortly for the Holiday Season display. Be certain to replenish all flower beds with fresh potting mix and raise flower beds to contractual height prior to the installation of Holiday Season display. *Photo below.*



# **SUMMARY**

RedTree performed to contractual standards for this inspection. The turf was being maintained in accordance with the specifications. The color was generally a lightly mottled medium green and the density was strong. The broadleaf and grassy weed volume increased slightly. There was no insect activity, but patch disease was present in a few locations. The woodlines were well maintained. The majority of the shrubs were neatly pruned and healthy, though some were in decline and will be removed. Spider mite were still present in isolated locations. Some tree pruning and moss removal was necessary to provide a neater appearance. The volume of bed and crack weeds was fair. The landscape appears to be receiving adequate irrigation. Monitor irrigation in areas prone to patch disease. The seasonal color display continued to provide a strong curb appeal.

# **Tennis Court Drainage Structure Installation**

# Review of Drainage Structures in Gated Portions of Wilderness Lake Preserve

Tish and I visited each manhole or curb inlet structure within the gated portions of the community. Attached please find our report outlining our findings. In summary, two structures require cleaning with a vac truck.

# **Pool Drainage**

During the installation of the drainage structure Cardno and Sitemasters staff reviewed the pool drainage to try and find drainage inlets as shown on the pool drainage plans. We did not find any of the inlets indicated on the plans. We do not believe that the drainage system was installed per plan or possibly not at all.

Our next step is to design and install two drainage inlets to discharge behind the pool area in the drainage pond. We will have the plan and proposals submitted at the January meeting.




On November 9, 2021 Cardno staff met with Tish onsite to review the stormwater structures associated with the gated portions of the Preserve at Wilderness Lake Community Development District. We visited each stormwater inlet and manhole structures, removed the lid, and placed a probe into each structure to measure silt or debris in the structures. In general, most of the structures were clear of silt and debris. Some structures had 2"-3" of silt in the bottom, which is not unusual due to the concrete structure, have a sump in the bottom due to the pipe thickness and they do not always come in at the bottom of the structure. We did find two structures that require removal of silt from the structure. The structures were located on Draycott Way and off Sky Vista Drive. Plans showing the location of the manhole and inlet that require removal of the silt are indicated below. Also included below is a summary of inlets reviewed

Dates Worked Performed: October 26, November 4, 10, 16 and 22

# **Summary of Monthly Objectives/Goals Achieved:**

- **1.** Performed monthly inspections and maintenance of vegetation/algae in stormwater ponds.
- **2.** Removed trash from stormwater ponds.
- **3.** Field meeting with T. Dobson, B. Ortolano and homeowners of 7019 Cardinalwood Lane to review the conservation area and the location of a specific tree conflicting with the placement of a proposed pool.
- **4.** Field meeting with homeowner of 7629 Deer Path to review floating vegetation in an offsite wetland owned by Pasco County behind their residence. Addressed their various questions.


On November 9, 2021 Cardno staff met with Tish onsite to review the stormwater structures associated with the gated portions of the Preserve at Wilderness Lake Community Development District. We visited each stormwater inlet and manhole structures, removed the lid, and placed a probe into each structure to measure silt or debris in the structures. In general, most of the structures were clear of silt and debris. Some structures had 2"-3" of silt in the bottom, which is not unusual due to the concrete structure, have a sump in the bottom due to the pipe thickness and they do not always come in at the bottom of the structure. We did find two structures that require removal of silt from the structure. The structures were located on Draycott Way and off Sky Vista Drive. Plans showing the location of the manhole and inlet that require removal of the silt are indicated below. Also included below is a summary of inlets reviewed
