**Dates Work Was Performed:** December 31, January 8, 9, 15, 22 and 28

**Summary of Monthly Objectives/Goals Achieved:**

1. Performed monthly inspections and maintenance of vegetation/algae in stormwater ponds.
2. Removed trash from stormwater ponds.
3. Field meeting with T. Dobson and resident at 21235 Sky Vista Drive to assess allowable vegetation removal per Southwest Florida Water Management District (SWFWMD) and CDD guidelines.
4. Removed two oak trees blocking the access berm around Pond 12.
5. Coordination with K. Wagner (BDI) concerning certification inspection.
6. Meeting with T. Dobson to review proposal needs for future structure maintenance (ie. frequency, phasing, etc.).
7. Reviewed DM Meeting Notes and Action Items prepared by T. Dobson.
8. Field checked control structures CS-P1 and CS-P2 located in Wetland P to ensure there are no blockages.
9. Phone and email correspondence with WLP staff.
10. Prepared and submitted monthly summary report.

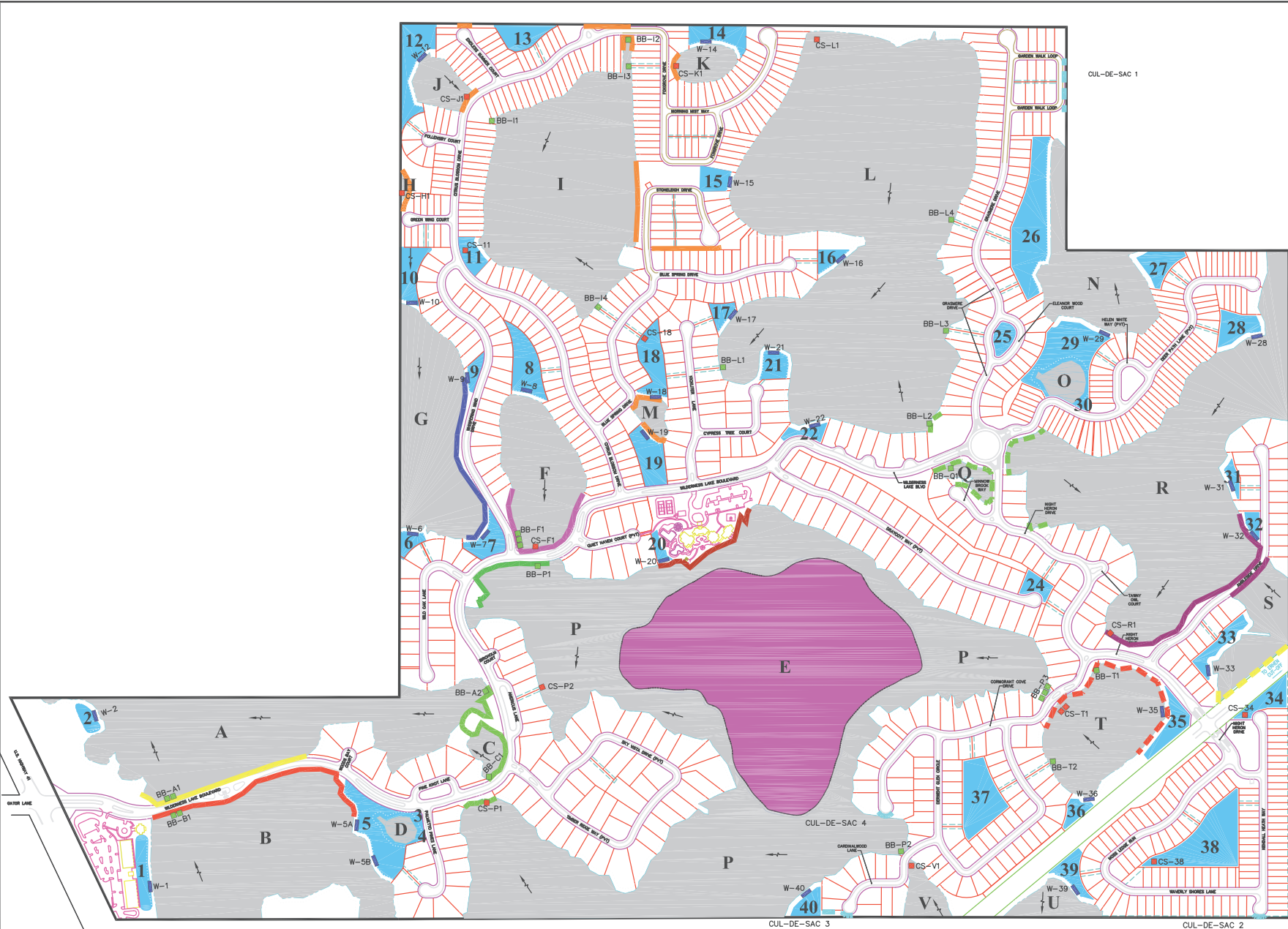

ENGINEER'S REPORT FOR February 4, 2026 BOARD MEETING**

Ongoing Projects Report and Updates:

**Stormwater Maintenance Project**

Contractors have completed or are nearing completion of the work in accordance with the scope of work for the project. Items outstanding are as follows:

- a. Pond 1 – overgrowth of vegetation at weir wall (GHS to complete). GHS has communicated they are still working on this item and will let BDi and the District Manager know as soon as it is complete.

**Parcel 35-25-18-0040-00100-000 Potential Development - (Northeast corner of US41 and Wilderness Lake Blvd)**

The CDD board requested BDi to help track the permitting process of a potential development reported by the District Manager located at the entrance to the community (northeast corner of US41 and Wilderness Lake Blvd). The following is the information gathered and updates as of December 29, 2025.

- SWFWMD Environmental Resource Permitting – According to the SWFWMD WMIS (Water Management Information System) which is the portal used by SWFWMD for permitting shows the most recent activity as follows:
  - ERP Permit 46945.000 – Wetland Delineation Approval – This permit establishes a formal delineation of the wetland lines on the property only. It was applied for by and issued to the owner of the property, Arbor Capital Developments, LLC.
  - There are records of past attempts to submit plans for various developments prior to the 2023 which show permit denials.
  - No follow up records of new applications for new projects past October 2023 were found.

**Update as of 1/27/26: no change in SWFWMD permitting found.**

- Pasco County – According to the Pasco County Accela which is the portal used by the county for permitting the most recent activity is as follows:
  - A site permit was applied for in September 2024 for the site, comments were to be issued to the applicant by Pasco county by the end of February 2025. Most department reviews show



Revision Required. No subsequent resubmittals were found since the comments were issued.

- BDi has requested all documents related to the initial submittal which have been sent to BDi and can be shared with the CDD (file size is too large to email). BDi has also requested the comments issued by the county but have not received them. BDi to continue following up on the request.

**Update as of 1/27/26: Found records of a resubmittal to Pasco County on 12/5/25 with a review deadline of 12/25/25. Most departments still mark the review as revisions are required. No final approval has been given yet. BDi will request/download records found.**

## **2 TURF WEED CONTROL**

Broadleaf turf weeds were present in all sections of viable St Augustine turf. They should now be controlled by spot treatment and blanket applications as the weather is cool enough to avoid turf discoloration and any possible damage.

## **2 TURF INSECT/DISEASE CONTROL/OVERALL HEALTH**

The turf was mowed at the proper height with sharp blades. There was a slight improvement in the color of the St. Augustine turf. The color of Bahiagrass and common Bermuda has diminished over the past month. This is common during the cooler weather. The density of the St. Augustine slightly improved. The Bahiagrass and the common Bermuda were thinning as they go into their winter dormancy. Broadleaf weeds continue to be a problem, but progress has been made and will continue to be addressed throughout the winter months. Patch disease, which is a common cool weather disease, was noted in several turf panels and needs to be controlled with fungicide. There were no insect problems noted. Be certain to remove any heavy leaf drop off the lawns to prevent smothering of grass plants. - Noted.

This means that too much vegetative growth was being removed, limiting the plants availability to make food for itself. In addition, the plant will look more attractive by not having “holes” in it and allowing it to develop its more natural shape. (i.e. Indian Hawthorn has a natural mounded habit)

#### **SUMMARY**

Redtree performed to contractual standards for this inspection. The growth of the turf has slowed considerably, and some sections do not need regular mowing. When the turf does not need to be mowed, the labor resources should be used for other tasks such as wood line clearing and contractual tree elevations. The turf color of the St. Augustine grass has improved over the past month. Patch disease was noted in several locations and needs to be treated with fungicide. This is a common cool weather turf disease. The density of the viable St Augustine turf remained strong while the Bahiagrass and common Bermuda grass were going into their dormant period which affects both their color and density. There was no insect activity noted in the turf. Shrubs and most small trees were neatly pruned and required no immediate attention. Woodline cutbacks, elevations and small tree pruning should continue through the winter. Bed weeds were well managed with only a few isolated pockets being visible. Some irrigation concerns need to be addressed. The newly installed Holiday season flower displays were performing well in all locations though some plants were not yet in full bloom. The property is well positioned to go into the winter months.

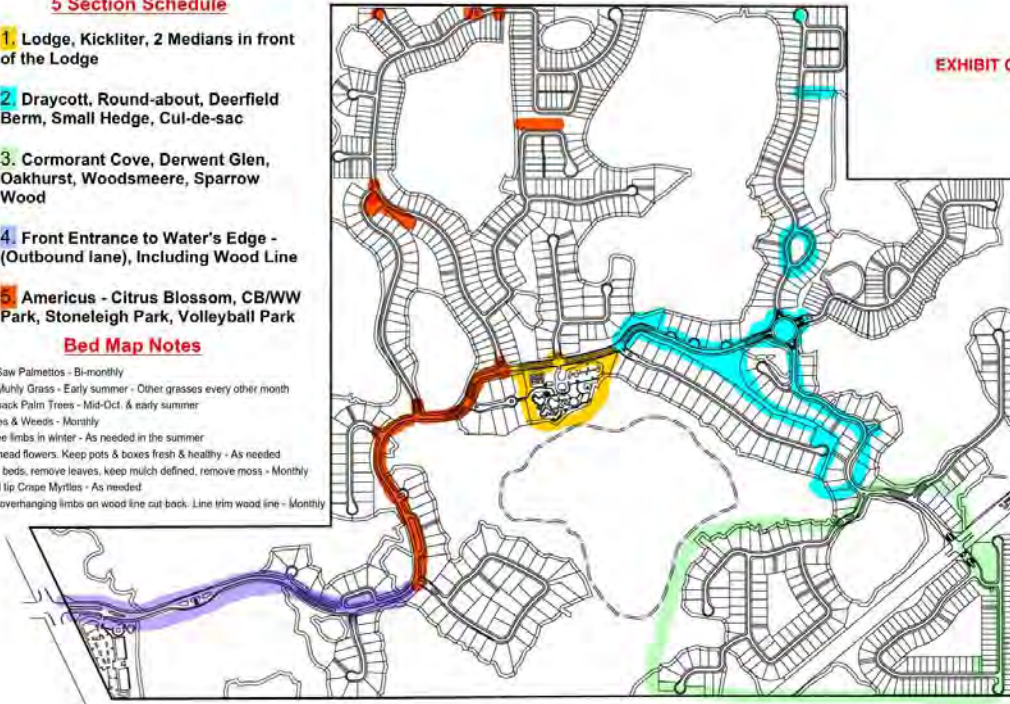

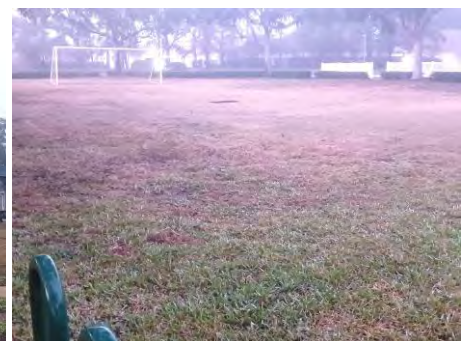

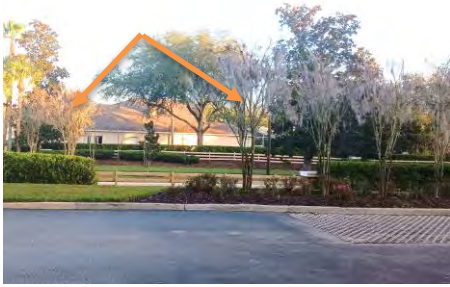

**SUMMARY**

Redtree performed to contractual standards for this inspection. The turf was neatly mowed, edged and maintained. The turf color of the St. Augustine lawns ranged from a mottled medium green to a consistent medium green with a varying density due to patch disease. The Bahiagrass as well as the common Bermuda grass were a pale green as they are both in a winter dormancy period. Their density was also thinning during this time of the year. They will both recover in the spring. There was a continued improvement in broadleaf weed control. Patch disease was prevalent throughout the entire community. This disease can be controlled by fungicide applications on a rotational basis. The recent cool weather, as well as irrigation and fog contribute greatly to its expanding presence on the property. Shrub health was generally good with problems limited to scale activity on certain coontie palms and disease activity on a jatropa plant. Shrubs were neatly pruned and required no immediate attention. Renewal pruning will begin on select shrubs such as jatropa. A few wood lines needed to be addressed. The small crape myrtles should now be pruned by removing dead branches, crossing branches, rubbing branches, water sprouts and moss. Bed weed control was strong. The main irrigation concern revolves around lowering run times and/or watering days to lessen the presence of patch disease on the property. Some coverage concerns were also noted. The seasonal flower display was performing well at the lodge and at the Caliente/ Night Heron intersection, but it was lacking at the main entrance. A few plants needed to be installed under warranty.

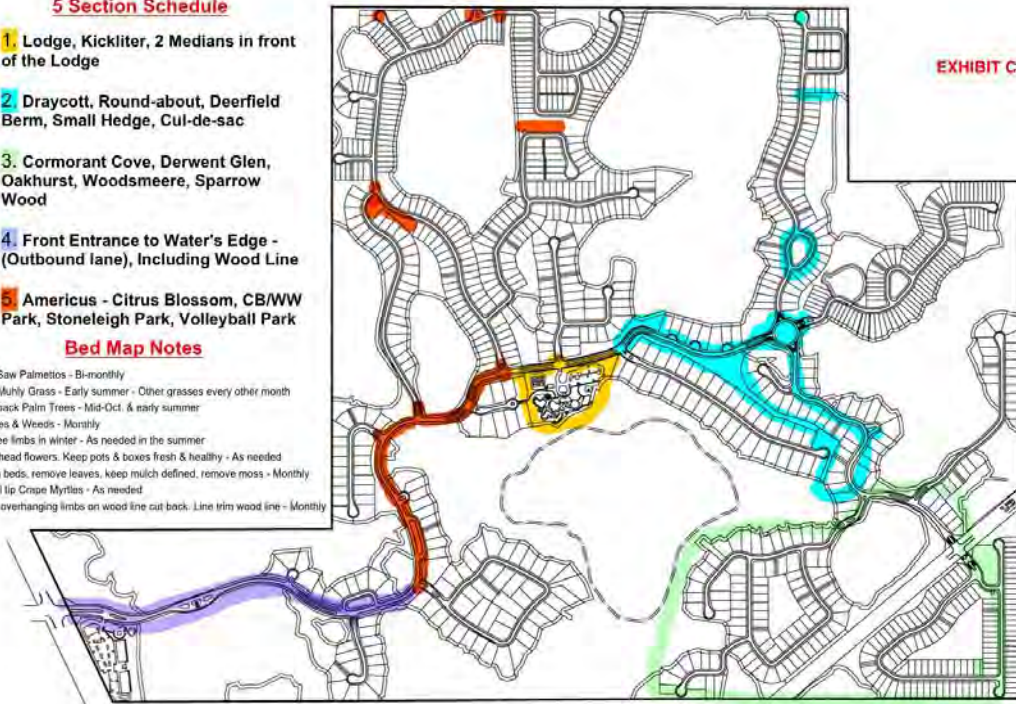

On a MOTION by Mr. Staples, SECONDED by Ms. Ruhlig, WITH ALL IN FAVOR, the Board approved the Blue Line Tree Company Dead Tree, Low-Hanging Branches, & Stump Removal Proposal, as presented, in the amount of \$9,800.00, for the Preserve at Wilderness Lake Community Development District.

**NINTH ORDER OF BUSINESS – Supervisors' Requests**

Mr. Staples expressed concerns about speeding throughout Wilderness Lake Boulevard. Ms. Dobson stated that these were public roads and noted Sheriff and FHP oversight being brought in by the CDD and the HOA respectively. Ms. Edwards requested that the District Manager reach out to the Board for available dates to schedule the budget workshop meeting for the fiscal year, and present the budget planning and submittal schedule to the Board at the next meeting. Ms. Edwards also asked for clarification on

whether the reserve study would be worked on for the next year, and Ms. Dobson confirmed that no large changes or major work for the study were expected.

Ms. Dobson asked for final questions, comments, or corrections from the Board. There being none, Ms. Ruhlig made a motion to adjourn the meeting.

On a MOTION by Ms. Ruhlig, SECONDED by Ms. Edwards, WITH ALL IN FAVOR, the Board adjourned the meeting at 11:40 a.m., for the Preserve at Wilderness Lake Community Development District.

The exemption specifies that I, as the owner of the property listed, may act as my own contractor with certain restrictions even though I do not have a license.
2. I understand that building permits are not required to be signed by a property owner unless he or she is responsible for the construction and is not hiring a licensed contractor to assume responsibility.
3. I understand that, as an owner-builder, I am the responsible party of record on a permit. I understand that I may protect myself from potential financial risk by hiring a licensed contractor and having the permit filed in his or her name instead of my own name. I also understand that a contractor is required by law to be licensed in Florida and to list his or her license numbers on permits and contracts.
4. I understand that I may build or improve a one-family or two-family residence or a farm outbuilding. I may also build or improve a commercial building if the costs do not exceed \$75,000. The building or residence must be for my own use or occupancy. It may not be built or substantially improved for sale or lease, unless I am completing the requirements of a building permit where the contractor listed on the permit substantially completed the project. If a building or residence that I have built or substantially improved myself is sold or leased within 1 year after the construction is complete, the law will presume that I built or substantially improved it for sale or lease, which violates the exemption.
5. I understand that, as the owner-builder, I must provide direct, onsite supervision of the construction.

6. I understand that I may not hire an unlicensed person to act as my contractor or to supervise persons working on my building or residence. It is my responsibility to ensure that the persons whom I employ have the licenses required by law and by county or municipal ordinance.

7. I understand that it is a frequent practice of unlicensed persons to have the property owner obtain an owner-builder permit that erroneously implies that the property owner is providing his or her own labor and materials. I, as an owner-builder, may be held liable and subjected to serious financial risk for any injuries sustained by an unlicensed person or his or her employees while working on my property. My homeowner's insurance may not provide coverage for those injuries. I am willfully acting as an owner-builder and am aware of the limits of my insurance coverage for injuries to workers on my property.

8. I understand that I may not delegate the responsibility for supervising work to a licensed contractor who is not licensed to perform the work being done. Any person working on my building who is not licensed must work under my direct supervision and must be employed by me, which means that I must comply with laws requiring the withholding of federal income tax and social security contributions under the Federal Insurance Contributions Act (FICA) and must provide workers' compensation for the employee. I understand that my failure to follow these laws may subject me to serious financial risk.

9. I agree that, as the party legally and financially responsible for this proposed construction activity, I will abide by all applicable laws and requirements that govern owner-builders as well as employers. I also understand that the construction must comply with all applicable laws, ordinances, building codes, and zoning regulations.

10. I understand that I may obtain more information regarding my obligations as an employer from the Internal Revenue Service, the United States Small Business Administration, the Florida Department of Financial Services, and the Florida Department of Revenue. I also understand that I may contact the Florida Construction Industry Licensing Board at (telephone number) or (Internet website address) for more information about licensed contractors.

11. I am aware of, and consent to, an owner-builder building permit applied for in my name and understand that I am the party legally and financially responsible for the proposed construction activity at the following address: (address of property).

12. I agree to notify (issuer of disclosure statements) immediately of any additions, deletions, or changes to any of the information that I have provided on this disclosure.

Licensed contractors are regulated by laws designed to protect the public. If you contract with a person who does not have a license, the Construction Industry Licensing Board and Department of Business and Professional Regulation may be unable to assist you with any financial loss that you sustain as a result of a complaint. Your only remedy against an unlicensed contractor may be in civil court. ### **A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE PRESERVE AT WILDERNESS LAKE COMMUNITY DEVELOPMENT DISTRICT CALLING FOR A GENERAL ELECTION TO BE HELD BY THE PASCO COUNTY SUPERVISOR OF ELECTIONS IN CONJUNCTION WITH THE GENERAL ELECTION TO BE HELD IN NOVEMBER 2026.**

**WHEREAS**, The Preserve at Wilderness Lake Community Development District ("**District**") is a local unit of special-purpose government established by Pasco County, Florida (the "**County**");

**WHEREAS**, pursuant to Section 190.006(1), Florida Statutes the District Board of Supervisors consists of five members; and

**WHEREAS**, Section 190.006(3), Florida Statutes provides for the election of members to specific terms and seat numbers for the District Board of Supervisors and currently calls for the election of two (2) members of the Board of Supervisors of the District for seat numbers and length of terms thereof:

Seat No. 1, Currently held by Beth Edwards  
Seat No. 2, Currently held by Agnieszka Fisher

Length of term: Four-years  
Length of term: Four-years

### **NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE DISTRICT, THAT:**

**Section 1. General Election.** There is hereby called an election in the County to be held concurrent with the General Election on the first Tuesday of November, which is November 3, 2026, for the purpose of having all of the qualified electors residing within the boundaries of the District to determine **two (2) qualified electors** to serve on the Board of Supervisors of the District.

**Section 2. Qualifying Period.** The period of qualifying as a candidate for a supervisor to the district shall be from noon June 8, 2026 through noon June 12, 2026, pursuant to Section 99.061, Florida Statutes. This Resolution shall serve as the District's notice of the qualifying period, pursuant to Section 190.006(3), Florida Statutes. Interested candidates should contact the Supervisor of Elections for the County for further information.

**Section 3. Conduction and Procedure of Election.**

- a. The election shall be conducted according to the requirements of general law and law governing special district elections.
- b. The election shall be held at the precinct polling places designated by the Supervisor of Elections in the County.
- c. The polls shall be opened and closed as provided by law, including, but not limited to Section 100.011, Florida Statutes.
- d. The ballot shall contain the names of the candidates to be voted upon, pursuant to Section 101.151, Florida Statutes.
- e. The Department of State shall make out a notice stating what offices are to be filled at the general election, pursuant to Section 100.021 Florida Statutes.

**Section 4. Election Costs.** The District shall be responsible for paying the District's proportionate share of the regular election costs, if any, pursuant to Section 100.011, Florida Statutes.

**Section 5. Effective Date and Transmittal.** This Resolution shall become effective upon its passage and the District's Secretary is authorized to transmit a copy of this Resolution to the Supervisor of Elections for the County.

**Section 6. Repeal of Resolution 2026-02.** This Resolution shall replace and supersede Resolution 2026-02 adopted by the District Board of Supervisors on November 5, 2025.
