THIRD ORDER OF BUSINESS **Audience Comments**

A resident requested clarification regarding several items related to CDD North and the ongoing irrigation project. The resident asked whether the Board was aware of, or in support of, CDD North installing piping within the area. The Board stated that they were not aware of such plans and were not in favor of CDD North installing pipes.

The resident also inquired whether any discussions had taken place between the Board and CDD North regarding the installation of piping. The Board confirmed that no such conversations had occurred.

83 the gazebos is complete

86 There were no updates for the Board.

88 **C. Golf Course Villas Update**

89 There were no updates for the Board.

92 Mr. Neville stated for the record that he does not intend to run for reelection. Ms. Davis

94 The Board discussed the sidewalks around Central Park and whether any concerns exist,
95 as well as the fading of the top coat on the right side of the paving. The Board requested
96 that these concerns be forwarded to the District Engineer and that he provide follow-up
97 findings.

98 Mr. Frankel reported irrigation issues along Heritage Green, which resulted in the loss of a
99 40-foot Spanish Oak tree.

100 The Board also discussed requesting that Master Association maintenance staff repaint
101 existing signs and replace any missing signage.

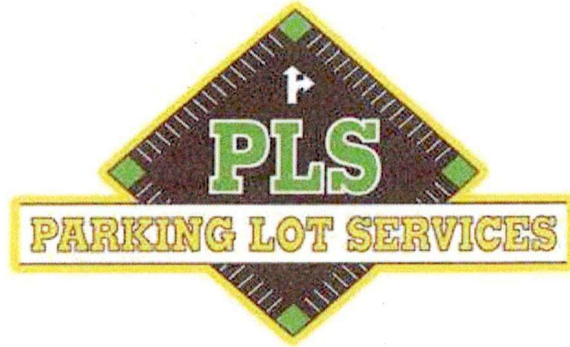

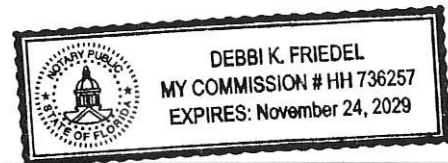

Heritage Harbour South CDD - Hole 16 Drainage Deficiencies

Mark Bruce and I met on site last Friday to review the drainage deficiencies along Hole 16, both behind the condos and single-family homes.

The drainage deficiencies along this portion of the golf course have existed for as long as I have been the CDD engineer of record, since 2013. In reviewing the drainage plans for the golf course and Stoneybrook community, the drainage behind both the condos and single-family homes all connect to the golf course drainage system and probably should have had a drainage system that connects to the community drainage system. It is obvious that the drainage system of the golf course is not adequate to handle the flows from the golf course and water that flows from the condos, homes and lots that border the course.

An attempt was made by the condos to help alleviate their drainage issue by connecting their downspouts and extending a pipe to direct discharge into the golf course drainage inlets. While the intent had good intentions, the golf course drainage system continued to back up over the inlets and flood the areas behind the condos and on the golf course property. Since the drainage system appears that it was not designed to handle the added flows from the condos, my recommendation is to connect the downspouts from the condos and direct the flow away from the golf course inlets. For the northern building, it appears that a parallel drainage pipe can be installed directly behind the condos and connect all the downspouts and have the pipe sloped to the north and install a bubbler box at the north end of the condo and allow for the water to flow out of the bubbler box and down the slope to the north.

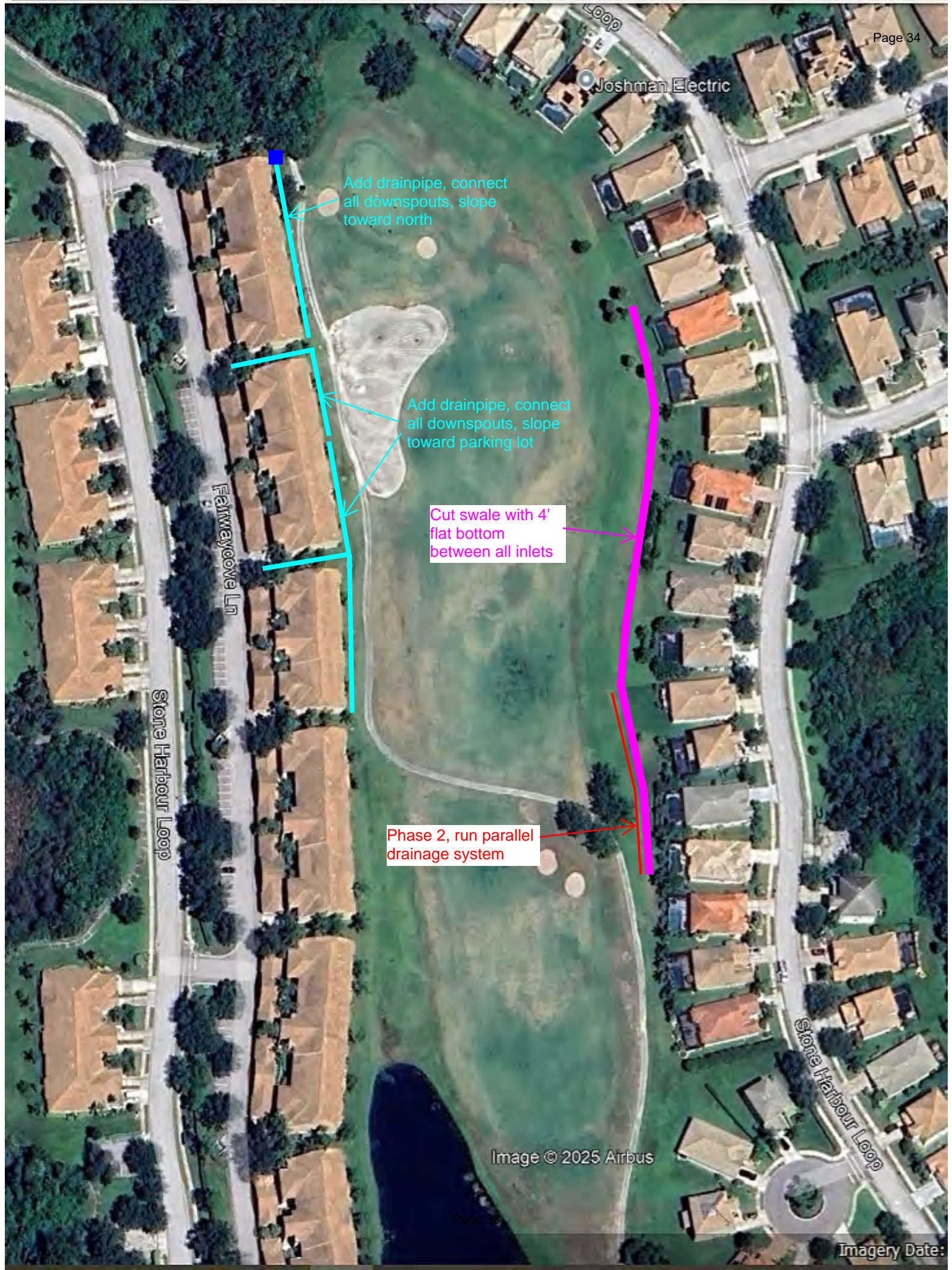
For the second and third condos, my recommendation is to install a drainage pipe that connects all the rear downspouts and then run the drainage pipe to the west and have the flow drain into the parking lot on the west side of the condos and into the drainage system designed for the condos. The fourth condo and all other condos to the south do not appear to have a drainage issue.

On the single-family side of the fairway, we have a similar drainage problem due to what appears to be an undersized drainage system at the rear of the residential lots along the entirety of the 16th hole. All the single-family homes appear to have a drainage pattern where the front half of the lot drains toward the road and back half of the lot drains toward the golf course and into their drainage system. The golf course drainage system does not connect to the drainage system along Stone Harbour Loop as there are no drainage easements or pipes between any of the homes. We discussed several options to help alleviate drainage issues and believe a phased system should be implemented to help resolve the drainage issue. In between most of the drainage inlets, the existing ground is humped up, creating individual drainage basins. The undersized pipes do not allow the water to flow quickly enough and causes each drainage basin to pool, which extends both onto the single-family lots as well as onto the golf course. Most of the drainage inlets have their grates close to the same elevation, so the recommended first phase of action would be to cut a swale with at least a 4' wide flat bottom between all the inlets. This would allow the water to flow overland when the pipe system is overwhelmed. Once the flow reaches the large drainage inlet, the pipe size increases and appears to adequately handle the flow. There is a weir on both the north and south side of the large concrete inlet and the swale would need to be cut to match this elevation. This first phase may be adequate to alleviate the drainage problem. If a drainage issue still exists, we would recommend a parallel drainage system beginning at the concrete inlet and continuing north as needed. There may only be a need for a few runs of parallel drainage pipes to handle the water. Phase three would possibly run pipes between homes to the east toward Stone Harbour Loop. This phase alters the existing drainage pattern as the water along Stone Harbour Loop drains into a different drainage basin and may require a SWFWMD permit modification.

RESOLUTION 2026-02

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE HERITAGE HARBOUR SOUTH COMMUNITY DEVELOPMENT DISTRICT IMPLEMENTING SECTION 190.006(3), *FLORIDA STATUTES*, AND REQUESTING THAT THE MANATEE COUNTY SUPERVISOR OR ELECTIONS CONDUCT THE DISTRICT'S GENERAL ELECTIONS; PROVIDING FOR COMPENSATION; SETTING FORTH THE TERMS OF OFFICE; AUTHORIZING NOTICE OF THE QUALIFYING PERIOD; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Heritage Harbour South Community Development District ("District") is a local unit of special-purpose government created and existing pursuant to Chapter 190, *Florida Statutes*, being situated entirely within unincorporated Manatee County, Florida; and

WHEREAS, the Board of Supervisors of the District ("Board") seeks to implement Section 190.006(3), *Florida Statutes*, and to instruct the Manatee County Supervisor of Elections ("Supervisor") to conduct the District's elections by the qualified electors of the District at the general election ("General Election").

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE HERITAGE HARBOUR SOUTH COMMUNITY DEVELOPMENT DISTRICT:

1. **GENERAL ELECTION SEATS.** Seat 3, currently held by Mike Neville, and Seat 5, currently held by Lisa Davis, are scheduled for the General Election beginning in November 2026. The District Manager is hereby authorized to notify the Supervisor of Elections as to what seats are subject to General Election for the current election year, and for each subsequent election year.
2. **QUALIFICATION PROCESS.** For each General Election, all candidates shall qualify for individual seats in accordance with Section 99.061, *Florida Statutes*, and must also be a qualified elector of the District. A qualified elector is any person at least 18 years of age who is a citizen of the United States, a legal resident of the State of Florida and of the District, and who is registered to vote with the Manatee County Supervisor of Elections. Campaigns shall be conducted in accordance with Chapter 106, *Florida Statutes*.
3. **COMPENSATION.** Members of the Board receive a maximum of \$200.00 per meeting for their attendance and no Board member shall receive more than \$4,800.00 per year.
4. **TERM OF OFFICE.** The term of office for the individuals to be elected to the Board in the General Election is four (4) years. The newly elected Board members shall assume office on the second Tuesday following the election.
5. **REQUEST TO SUPERVISOR OF ELECTIONS.** The District hereby requests the Supervisor to conduct the District's General Election in November 2026, and for each subsequent General Election unless otherwise directed by the District's Manager. The District understands that it will be responsible to pay for its proportionate share of the General Election

cost and agrees to pay same within a reasonable time after receipt of the invoice from the Supervisor.

- 6. **PUBLICATION.** The District Manager is directed to publish a notice of the qualifying period for each General Election.
- 7. **SEVERABILITY.** The invalidity or unenforceability of any one or more provisions of this Resolution shall not affect the validity or enforceability of the remaining portions of this Resolution, or any part thereof.
- 8. **EFFECTIVE DATE.** This Resolution shall become effective upon its passage.
