ORDINANCE NO. 2010- <u>129</u>

AN ORDINANCE OF THE CITY OF TAMPA, FLORIDA, **ESTABLISHING** THE **ENCORE COMMUNITY** DISTRICT DEVELOPMENT (GENERALLY LOCATED SOUTH OF KAY AND SCOTT STREETS, WEST OF NEBRASKA AVENUE, NORTH OF CASS STREET AND EAST OF PERRY HARVEY SR. PARK, COMPRISING 28.9 ACRES OF LAND, MORE OR LESS); FOR THE PURPOSE OF MANAGING AND DELIVERING BASIC COMMUNITY INFRASTRUCTURE IMPROVEMENTS; SAID DISTRICT TO BE LOCATED ENTIRELY WITHIN THE BOUNDARIES OF THE CITY OF TAMPA; THE SAME BEING MORE PARTICULARLY DESCRIBED IN SECTION 2 HEREOF; PURSUANT TO CHAPTER 190, FLORIDA STATUTES; **NAMING** THE **DISTRICT: PROVIDING FOR** SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Central Park Development Group, LLC ("Petitioner"), has submitted a petition to the City Council of the City of Tampa, Florida ("City") pursuant to the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes, to adopt an ordinance to establish a community development district ("CDD"), and designating the land area for which the CDD would manage and finance the delivery of basic infrastructure services; and

WHEREAS, pursuant to Chapter 190, Florida Statutes, the City conducted a public hearing to consider oral and written comments on the petition; and

WHEREAS, the proposed CDD complies with the requirements of law, is in the best interest and promotes the health, safety and welfare of the residents of the City of Tampa;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA:

Section 1. Recitals. That the recitals above are hereby incorporated as if fully set forth herein.

Section 2. Establishment of District. The Encore Community Development District is hereby authorized and established, the administration of which shall be subject to

the provisions of Chapter 190, Florida Statutes, as amended from time to time; and, the boundaries of which are more particularly described below:

<u>Section 4.</u> Declaration of Compliance with Statutory Requirements. The City hereby finds that:

- (a) All statements contained within the petition have been found to be true and correct; and
- (b) That establishment of the CDD is consistent with the applicable elements and portions of the state comprehensive plan and the effective City of Tampa comprehensive plan; and
- (c) That the area of land within the approved CDD is of sufficient size, is sufficiently compact, and is sufficiently contiguous to be developable as one functional interrelated community; and
- (d) That the approved CDD is the best alternative available for delivering community development services and facilities to the area that will be served by the District; and

- (e) That the services and facilities of the approved CDD will be compatible with the capacity and uses of existing local and regional community development services and facilities; and
- (f) That the area that will be served by the CDD is amenable to separate special-district government.

Section 5. Severability. If any section, subsection, sentence, clause, provision, or part of this ordinance shall be invalid for any reason, the remainder of this ordinance shall not be affected thereby, but shall remain in full force and effect.

Section 6. Recording; Notice of Establishment. The City Clerk shall certify and record a copy of this Ordinance in the Office of the Clerk of the Circuit Court of Hillsborough County, Florida. The Petitioner, at Petitioner's sole cost and expense, shall promptly file a Notice of Establishment in compliance with Chapter 190.0485, Florida Statutes, in the Office of the Clerk of the Court of Hillsborough County, Florida.

<u>Section 7.</u> Effective Date of Ordinance. This Ordinance shall become effective immediately upon execution by the Mayor.
