Course Description: Student performance of the care and fitting of men's hairpieces (10 Hours) and men's and women's basic and advanced haircutting/styling (200 Hours) is the focus of this class.

On completion of this course, the student will be able to:

1. Perform procedures for men's hairpieces, as well as basic and advanced men's and women's haircutting/styling with manikins and in the school-based barber-styling shop.
Tasks:
 1. Perform measuring procedures for ordering men's hairpieces.
 2. Perform application, fitting, cutting-in/styling procedures for men's hairpieces.
 3. Perform cleaning, coloring, and reconditioning procedures for men's hairpieces.
 4. Perform procedures, steps, and techniques for men's balanced haircut/style.
 5. Perform procedures, steps, and techniques for men's taper haircut/style.
 6. Perform procedures, steps, and techniques for women's taper haircut/style.
 7. Perform procedures, steps, and techniques for women's long layered haircut/style.
 8. Perform procedures, steps, and techniques for men's and women's advanced haircuts/styles using variations of the basic cuts/styles.
