 - b. Observe teacher/preceptor methods of instruction as center activities are performed.
 - c. Observe parent/teacher interactions.
 - d. Record, log, and describe personal student clock hours of observation/participation activities performed using appropriate forms.

- III. Participate in daily program activities of the early childhood center as directed by teacher/preceptor.
- a. Take initiative in organizing, planning, and implementing age-appropriate tasks/theories learned in class, when interacting with children. Students will base their plan on background information, observations, consultation with teacher/preceptor, and research of planning books and resources.
 - b. Demonstrate cooperative attitude when implementing suggestions from teacher/preceptor.
 - c. Work with teacher/preceptor in facilitating the daily routine, supporting play and participate in ongoing dialogue about child development.
 - d. Demonstrate competence in interactions with children, parents, teachers, supervisory personnel, and other students.
 - e. Identify and implement appropriate guidance methods for children in the early childhood center.
