 - a. Document assigned observations of children's behavior using appropriate forms/formats.
 - b. Observe and document teacher/preceptor methods of instruction as center activities are performed.
 - c. Record, log, and describe personal student clock hours of observation/participation activities performed using appropriate forms.
- II. Participate in daily program activities of the early childhood center as directed by teacher/preceptor.
 - a. Follow directions as instructed by teacher/preceptor when implementing developmentally appropriate activities.
 - b. Organize/plan developmentally appropriate activities for the early childhood center daily program.
- III. Conduct developmentally appropriate learning experiences in the early childhood center to enhance the total development of the children.
 - a. Write assigned lesson plans for learning experiences activities.
 - b. Gather/organize all materials/resources to be used in learning experience activities.
 - c. Perform skills for conducting learning experiences/activities for the children in specific curriculum and developmental areas using written lesson plans.
