On completion of this course, the student will be able to:

1. Inspect, test, adjust, repair or replace components of lighting circuits:
  - a. Headlights and daytime running lights.
  - b. Parking lights, clearance and tail lights.
  - c. Stoplights.
  - d. Turn signal and hazard lights.
  - e. Back-up lights.
  - f. Instrument lighting.
  - g. Courtesy lights.
  - h. Tractor to trailer lights.
2. Inspect, test, adjust, repair or replace components of gauges and warning device circuits.
3. Inspect, test, replace and calibrate components of electronic speedometer, odometer, and tachometer circuits.
4. Inspect, test, repair or replace components of related electrical circuits.
5. Inspect, test, repair or replace components of miscellaneous electrical circuits.
6. Maintain a safe work environment.
