Course Description:

The purpose of this course is to expose the student to a variety of patient care settings. Adhering to the National Emergency Medical Code of Ethics while providing advanced treatment under the guidance of a qualified preceptor, the student will have the opportunity to practice and reinforce terminal competency requirements within the paramedic scope of practice learned in the classroom and from lab experiences. In this course, students will function as a member of a team, following the guidance of the team leader on a field EMS unit.

Learning Outcomes:

On completion of this course, the student will be able to:

1. Safely and effectively perform psychomotor skills introduced and taught in the prerequisite and co-requisite classes that are within the National EMS Scope of Practice Model AND the State of Louisiana Scope of Practice at the paramedic level.
2. Be a role model of exemplary professional behavior including: but not limited to, integrity, empathy, self-motivation, appearance/personal hygiene, self-confidence, communications, time management, teamwork/diplomacy, respect, patient advocacy, and careful delivery of service.
3. Perform basic and advanced interventions as part of a treatment plan intended to mitigate the emergency, provide symptom relief, and improve the overall health of the patient.

4. Evaluate the effectiveness of interventions performs and modifies treatment plan accordingly.
5. Report and document assessment findings and interventions. Collect and report data to be used for epidemiological and research purposes.
6. Ensure the safety of the rescuer and others during an emergency
