### **Course Description:**

The purpose of this course is to expose the student to a variety of patient care settings. Adhering to the National Emergency Medical Code of Ethics while providing advanced treatment under the guidance of a qualified preceptor, the student will have the opportunity to practice and reinforce terminal competency requirements within the paramedic scope of practice learned in the classroom and from lab experiences. In this course, students will function as the team leader on an EMS field unit. Under the direction of a preceptor, students will develop and direct treatment plans, communicate with receiving facilities, and complete accurate documentation for each call.

### **Learning Outcomes:**

On completion of this course, the student will be able to:

1. Functions as the team leader of a routine, single patient advanced life support emergency call.
2. Performs all psychomotor skills safely and effectively within the National EMS Scope of Practice Model AND the State of Louisiana Scope of Practice at the paramedic level.
3. Acts as a role model of exemplary professional behavior including: but not limited to, integrity, empathy, self-motivation, appearance/personal hygiene, self-confidence, communications, time management, teamwork/diplomacy, respect, patient advocacy, and careful delivery of service.
4. Performs basic and advanced interventions as part of a treatment plan intended to mitigate the emergency, provide symptom relief, and improve the overall health of the patient.

**Learning Outcomes:**

On completion of this course, the student will be able to:

5. Evaluates the effectiveness of interventions performed and modifies treatment plan accordingly.
6. Reports and documents assessment findings and interventions. Collects and reports data to be used for epidemiological and research purposes.
7. Ensures the safety of the rescuer and others during an emergency.
