

## **MP1 - COVID-19 FACILITIES UPDATE JUNE 5, 2020**

**Since key fobs have not been issued or updated for the last several weeks, all families who do not have a key fob should obtain one now.** Download the fob application form from this web site and bring the completed application to the office along with a **check or money order** to pay the \$5 per fob fee. Multiple fobs are permitted per household. Additionally, since fobs have an expiration date of two years after issuance or renewal, those who have a key fob should ensure that it has not expired. This can be done by calling the office or by visiting the office and trying to use the fob. Even if you cannot use an amenity at this time because it is not yet open, please get or update your fob now, so you will not have to wait in a long line once your amenity is opened. **For the time being a picture ID with a MP1 address will be required for entry to our facilities. For residents between the ages of 14 through 17 who do not have a picture ID with a MP1 address, please update the information on the fob application to include the date of birth for those members of the household.**

The following rules apply to our facilities during this pandemic until further notice and **they will be strictly enforced.** They have been developed taking into consideration guidance from the CDC, Florida Governor Executive Orders (EO), Pasco County directives, our facilities layouts and the advice of attorneys, to ensure the safety of our staff and our guests. Anyone not fully complying will be removed from the facilities. They are in addition to, or temporary modifications of, the normal rules.

### **GENERAL RULES:**

**If you are exhibiting any symptoms of COVID-19 or have been in contact with anyone who has tested positive for the coronavirus in the last 14 days, do not come to the facilities.**

- Not all facilities will open at the same time. Updates about facilities will be posted on the website when changes occur. Please check frequently.
- Only residents of MP 1 CDD are permitted to use the facilities, no guests. Residents must use their key fobs and show a picture ID with a MP1 home address. The ID will be checked.
- Residents 14 through 17 years of age who do not have a picture ID with a MP1 address must be listed on the fob application indicating a date of birth and proof required.
- Everyone must comply with social distancing guidelines at all times. Only members of the same household may gather together in groups of 10 or less.
- Everyone must wear masks that cover their nose and mouth when dealing with staff.
- Residents are encouraged to bring disinfecting wipes to sanitize their areas before and after use.
- Facilities and office hours will be reduced to provide for cleaning and sanitizing and to double up on staffing during hours of operation.
- Only those facilities that lend themselves to social distancing and are permitted by EO and other directives will be open.

**BUSINESS HOURS:** Office is opened for all business from 9AM- 7PM, Monday-Sunday.

## **SWIMMING/WATER FACILITIES:**

Lap Pool and Lower Pool will open **Monday, June 8<sup>th</sup>** at a **reduced** capacity of **55** people. Water Slide, and Splash Pad are **CLOSED**. No toys (floats, etc.) are permitted aside from individual safety floatation devices. **HOURS: 10:00-12:00, 1:00-3:00, 4:00-7:00**. Pool area will be closed and cleared between hours of operations. No re-entry on the same day. Deck furniture has been removed to encourage social distancing. Do Not attempt to use furniture that has been stacked or obviously taken out of service. Re-opening rules are provided at the bottom of this update (Blue link). Anyone not fully complying will be removed from the facilities. These rules are in addition to and temporary modifications of the normal set of facility rules.
