Community Manager's Report - Sept. 15 & 20, 2022

A. Discussion Points and Decision Opportunities

1. TBAY Concessionaire Agreement (additional information provided)

a. The New Tampa TBAY, LLC, doing business as Tampa Elite Aquatics Manta Rays (TEAM) concessionaire agreement is up for renewal as the term of the current agreement ends on October 31st, 2022.

2. PROtential Sports Concessionaire Agreement (additional information provided)

a. The PROtential Sports concessionaire agreement is up for renewal as the term of the current agreement ends on October 31st, 2022.

3. Florida Highway Patrol Agreement (additional information provided)

a. The Florida Highway Patrol off-duty patrol agreement is up for renewal as the term of the agreement ends on September 31, 2022.

4. National Pollutant Discharge Elimination System "NPDES" Monthly Meeting Discussion

a. To continuously educate residents on our Stormwater System and the Identification and Elimination of Illicit Discharges we provide several platforms for residents to obtain information on the topic. During the meeting we will provide updates on information distributed, noted illicit discharge/issues, stormwater debris/trash removal, etc.

B. General Updates

1. Pickleball Courts

- **a.** Alto Paving, LLC has provided a timeline for the completion of the Pickleball courts, which is on track for completion by September 20th with fencing being the final stage (weather permitting).
- **b.** The Board has approved a Concessionaire Agreement with Peter Chow Tennis and he will have programming in place and assist with the Grand Opening of the courts on September 24th.
- **c.** Residents will be able to reserve courts online during hours of operation (7am to dawn). We are in the process of getting updated lighting bids for consideration during the FY 2023.
- **d.** Conduit is in place for cameras and tentatively scheduled for installation beginning September 21st after the fencing is complete.

2. Tree Trimming Maintenance

- **a.** The scheduled and approved trimming of the trees between the sidewalk and road in front of homes is scheduled to begin during the first week of October and be complete prior to the week of Thanksgiving.
- **b.** The trees will be elevated to a height of 15' all around the tree and will include trees growing into the road and streetlights from across the sidewalk.

3. Pump Station

- **a.** The main control panel/computer for the pump station has been replaced and is operational. Luckily, we received consistent rains to provide sufficient water for landscaping as the pump station was repaired.
- **b.** The panel was needed to be able and control the property-wide common area irrigation and log the amount of water withdrawn from the pond to be compliant with SWFWMD.
