- + ~~May 5 – June 1 by 5:00 p.m.: Candidates can complete nomination form~~
- + ~~June 13 – 14: Candidate interviews~~
- + ~~July 28: Slate of candidates is announced~~
- + August 20 – October 15 by 5:00 p.m.: Voting occurs
- + October 21: Election results are announced at Delegate Assembly
