## **ORDINANCE NO. 2020 – 16**

An Ordinance of the Board of County Commissioners of Osceola County, Florida, establishing the Town of Kindred Community Development District II, consisting of approximately 218.797 acres, pursuant to Chapter 190, Florida Statutes; naming the district; describing the external boundaries of the district; describing the functions and powers of the district; designating the five persons to serve as the initial members of the district's board of supervisors; providing a severability; providing for conflict; and providing an effective date.

#### RECITALS

WHEREAS, D.R. Horton, Inc. ("Petitioner"), as owner of 100 percent (100%) of the real property to be included in the District, has petitioned the Osceola County Board of Commissioners (the "County") to adopt an ordinance establishing the Town of Kindred Community Development District II (the "District") pursuant to Chapter 190, Florida Statutes; and

WHEREAS, the Petitioner is a Delaware corporation, authorized to conduct business in the State of Florida; and

WHEREAS, all interested persons and affected units of general-purpose local government were afforded an opportunity to present oral and written comments on the Petition at a duly noticed public hearing conducted by the County pursuant to Section 190.005(2)(b), Florida Statutes; and

WHEREAS, upon consideration of the record established at that hearing, the County has considered the record of the public hearing and the statutory factors set forth in Section 190.005(1)(e), Florida Statutes, in making its determination to grant or deny the Petition to establish the Town of Kindred Community Development District II; and

WHEREAS, the County has determined pursuant to the information contained within the Petition and based on an investigation conducted by the County Staff and otherwise being fully advised as to the facts and circumstances contained within the request of the District: that the statements within the Petition are true and correct; that the establishment of the District is not inconsistent with any applicable element or portion of the state comprehensive plan or the local government comprehensive plan; that the land within the District is of sufficient size, is sufficiently compact and sufficiently contiguous to be developable as a functionally interrelated community; that the District is the best alternative available for delivering community development services and facilities to the area served by the District; that the services and facilities of the District will not be incompatible with the capacity and uses of existing local and regional community development services and facilities; and that the area to be served by the District is amenable to separate special-district governance; and

WHEREAS, pursuant to the information as stated above, the County has decided to grant the District's Petition to establish the Town of Kindred Community Development District II; and

4850-9044-1615.3 148277/00006 WHEREAS, establishment of the District will constitute a timely, efficient, effective, responsive and economic way to deliver community development services in the area described within the Petition.

# NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF OSCEOLA COUNTY, FLORIDA:

- **SECTION 1. RECITALS**. The above RECITALS are adopted as Findings of Fact in support of this Ordinance.
- **SECTION 2.** AUTHORITY. This ordinance is enacted in compliance with and pursuant to the Uniform Community Development District Act of 1980, Chapter 190, *Florida Statutes*.
- SECTION 3. DISTRICT NAME. There is hereby established a Community Development District situated entirely within the unincorporated limits of Osceola County, Florida, which District shall be known as the "Town of Kindred Community Development District II."
- SECTION 4. EXTERNAL BOUNDARIES OF THE DISTRICT. The external boundaries of the District are described in Exhibit A attached hereto and incorporated by reference, the overall parcel containing 218.797 acres, more or less. There are no out parcels excluded within the external boundaries.
- **SECTION 5. FUNCTIONS AND POWERS.** The District shall exercise the general powers provided for in Section 190.011, all special powers authorized in Section 190.012(1), *Florida Statutes*, and those certain special powers consented to by the County which include Sections 190.012(a) & (d), *Florida Statutes*.
- SECTION 6. BOARD OF SUPERVISORS. The five persons designated to serve as initial members of the District's Board of Supervisors are as follows: Christopher Wrenn, John Auld, Louis Avelli, Branden Eckenrode and Bradley Kingsley. All of the above-styled persons are residents of the State of Florida and citizens of the United States of America.
- SECTION 7. SEVERABILITY. If any provision of this ordinance or the application thereof is finally determined by court of competent jurisdiction to be illegal, invalid or unenforceable, such provisions shall be deemed to be severable and the remaining provisions shall continue in full force and effect provided that the illegal, invalid or unenforceable provision is not material to the logical and intended interpretation of this Ordinance.
- **SECTION 8. EFFECTIVE DATE.** This Ordinance shall take effect pursuant to Florida general law.


