In consideration of the acceptance of this contract by the School, the undersigned agree to pay, in accordance with the following terms and conditions, total tuition, including registration, for the above named child(ren) \$ _____. The registration fee is non-refundable. Parent or legal guardian should sign this agreement and return to Lee Academy by March 5, 2020 for all returning students. After March 5, 2020 the registration fee will be \$400.00 per child for returning students.

3. I (we) agree to pay the balance of tuition in the following manner (check one).

_____ Full balance will be paid on or before June 1, 2020 to receive a 2% discount.

_____ Balance will be paid in _____ monthly installments of \$ _____ starting June 5, 10, or 15th, 2020 and ending May 5th, 10th, or 15th, 2021 to the tuition collection agency FACTS.

4. A building fee of \$120.00 per student may be added to tuition. This fee can be paid in full by May 25, 2020 or added to your monthly payments through FACTS. This fee will be used to make repairs on the buildings and facilities as needed.

5. My signature below indicates my acceptance of the policies of the School Board and Administration; the procedures, policies, and regulations as set forth in the school handbook; and the financial terms set forth herein. I authorize the school to refrain from administering examinations to the above student(s) or issuing any of his/her report cards or permanent records to anyone including myself, until all charges have been paid in full and all school property returned.

6. As a patron of Lee Academy I consent to have my child/children participate in the drug/alcohol screening program. Further, I release Lee Academy from any liability whatsoever arising as a result of the drug/alcohol testing program.

7. I further agree that enrollment may be cancelled by me upon receipt by the school of written notice to that effect prior to June 1, 2020 without penalty except forfeiture of the registration fee. If enrollment is cancelled after June 1, 2020 parents, legal guardians, or persons in loco parentis are obligated to pay the tuition and fees for the full academic year, and no portion of such tuition and fees so paid or outstanding will be refunded or cancelled. Exceptions may be granted by the School Board if a student and his/her family move out of the community, if a serious medical problem prevents the student from completing the school year, or for such other circumstances as deemed appropriate by the School Board. The fact that the school tuition and fees may be paid in two or more installments does not constitute a fractional contract.
