# Seven Oaks Field Operations Update CDD Meeting 09/11/24

## Landscaping:

- Flower rotation has begun, will be a fall mix
- The fan palms have been planted at the North roundabout
- Self-Cleaning Palm Trees:

#### Areca Palm

Not a good choice as the soft fine-textured fronds are full and dense making them a better choice for use as privacy screens.



## **Foxtail Palm**

A fast-growing palm that can reach up to 30 feet tall. It can tolerate cold down to 30F though should be protected from frost.



### **Christmas Palm**

Grows to approximately 25 feet. Often planted in groups for a multi-trunk effect. Caution is advised as they are sensitive to cold.



## **Royal Palm**

Grows to approximately 60-80 feet tall. Because of their eventual mammoth size, Royals are best suited for larger landscapes.



## **Blue Latin**

Grows to approximately 20-30 feet. Large very thick and stiff leaves, up to eight feet in diameter. Unfortunately, it is susceptible to lethal yellowing disease.

## **Pressure Washing:**


 Annual pressure washing of curbs, sidewalks, monument walls, and playgrounds is currently underway.

#### Pond #19:

 Pond 19 is located along the nature trail at the back of Forest Edge. During the last storm a large 20,000 sq ft island of vegetation broke loose and floated into a new position. The yellow area in picture reflects the original position.

#### Three choices are:

- Leave it alone
- Spray it and then allow it to eventually die and dissipate into the pond
- O Have the island completely removed (Apprx \$75,000.00+)

#### Re: Fascia Replacement

Areas of fascia to be replaced are the two rounded overhangs on the front of the clubhouse, the large round turret, and the small, rounded overhang on the pool side of the clubhouse.

#### **Objective**

- Remove the fascia in the areas above and replace with 1"x12" PVC (or Cedar if PVC cannot be acquired).
- Install with galvanized finish nails and paintable silicone caulk; painting the fascia to match as closely as possible.
- The process will entail removing and replacing the drip edge and one row of shingles above the drip edge. Five Star Roofing will try to match the shingle color as closely as possible, but there are sometimes differences even between lots of the same color. The age of the existing shingles is also a factor in color matching.
  - 30 Day Warranty by Five Star Roofing (only on areas repaired by Five Star Roofing).
